Bill Summary: This proposal requires political subdivisions that require the installation of electric vehicle charging stations at certain businesses to pay the costs associated with the installation, maintenance, and operation of such stations.

**FISCAL ANALYSIS**

**ASSUMPTION**

**§67.288 – Electric Vehicle Charging Station Requirements**

Officials from the **Office of Administration - Budget and Planning**, the **Department of Economic Development**, the **Missouri Department of Agriculture**, the **Office of Administration**, the **Department of Elementary and Secondary Education**, the **Department of Natural Resources** and the **Missouri Department of Transportation** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Officials from the **Office of the Secretary of State (SOS)** note many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$5,000. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with its core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

**Oversight** assumes this proposal would have no local fiscal impact without action taken by the governing body of the City of St. Louis or St. Louis County to adopt an ordinance, resolution, regulation, code or policy requiring the installation of electric vehicle stations. Oversight does not know of any governing bodies that have approved such an ordinance. Until that action is taken by the City of St. Louis or St. Louis County, Oversight will assume a \$0 direct fiscal impact to local political subdivisions.

**Oversight** only reflects the responses received from state agencies and political subdivisions; however, the City of St. Louis and St. Louis County were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.

FISCAL IMPACT – Small Business

There could be a positive direct fiscal impact to small businesses if a local political subdivision adopts (and pays for) an ordinance, resolution, regulation, code or policy that requires installation of electric vehicle charging stations.

FISCAL DESCRIPTION

This bill provides that any political subdivision that adopts an ordinance, resolution, regulation, code, or policy that requires the installation of electric vehicle charging stations must pay all costs associated with the installation, maintenance, and operation of the electric vehicle charging stations.

The bill prohibits any political subdivision from requiring more than five electric vehicle charging stations per parking lot, or infrastructure for future installation of more than five vehicle charging stations, and the bill further states that such policies will only apply to parking lots with more than 30 parking spaces.


The bill prohibits any political subdivision from requiring any school or religious organization to install an electric vehicle charging station.

This bill would currently only apply to St. Louis City and St. Louis County.

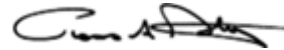
This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
