#### **FISCAL ANALYSIS**

#### **ASSUMPTION**

Officials from the **Missouri State Senate (SEN)** anticipate a negative fiscal impact to the Joint Contingent Appropriation to reimburse 10 Legislators for travel to Joint Committee meetings. In summary, it will cost approximately \$1,713 per meeting.

Officials from the **Missouri House of Representatives (MHR)** assume no fiscal impact directly to the House. MHR assumes that since this is a joint committee that any reasonable expenses of members serving on the committee will be covered by the joint contingent appropriation. The Senate handles the budget estimates for the joint contingent appropriation, so the MHR defers to them on the impact this may cause.

**Oversight** assumes the proposal simply governs the selection and participation of commissioners from Missouri if such a call were made. Oversight assumes the expenses of the joint legislative committee would not have a material direct fiscal impact on the state. Therefore, Oversight will reflect a zero impact on the fiscal note.
