## FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the Department of Commerce and Insurance, the Department of Public Safety - Missouri Highway Patrol, the Department of Social Services, the Missouri Department of Conservation, the Missouri Department of Transportation, the Missouri Consolidated Health Care Plan, the City of Kansas City and the City of O'Fallon each assume the proposal will have no fiscal impact on their respective organizations.

**Oversight** notes that the above mentioned agencies have stated the proposal would not have a direct fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Officials from the Attorney General's Office did not respond to **Oversight's** request for fiscal impact for this proposal.

Oversight assumes this proposal allows enrollees to file a complaint with the Attorney General if they believe that an air ambulance membership organization has violated the provisions of the bill, and deems such violations as violations of the Missouri Merchandising Practices Act, subject to all penalties, remedies, and procedures under the law. Oversight assumes additional workload to the Attorney General's Office would be minimal and also assumes the Attorney General's Office is provided with core funding to handle a certain amount of activity each year. Oversight assumes AGO could absorb the costs related to this proposal.

**Oversight** only reflects the responses received from state agencies and political subdivisions; however, other cities were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.
