**FISCAL ANALYSIS**

**ASSUMPTION**

**§§217.451 and 221.108 – Telephones in correctional facilities**

Officials from the **Department of Corrections (DOC)** assume the proposal will have no fiscal impact on their organization. The DOC states the current phone services contract charges offenders \$0.05 per minute. If this proposal is passed, the department will need to amend its telephone contract to ensure compliance with this legislation.

Officials from the **Phelps County Sheriff’s Department**, the **Kansas City Police Department**, and the **St. Louis County Police Department** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

**Oversight** only reflects the responses received from state agencies and political subdivisions; however, other local law enforcement agencies were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


**FISCAL DESCRIPTION**

The proposed legislation appears to have no direct fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
