## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Elementary and Secondary Education**, the **Department of Corrections**, the **Department of Public Safety – Office of the Director**, the **Department of Social Services** and the **Missouri House of Representatives** each assume the proposal will have no fiscal impact on their respective organizations.

**Oversight** notes that the above mentioned agencies have stated the proposal would not have a direct fiscal impact on their respective organizations. Oversight does not have any information to the contrary; therefore, Oversight will reflect a zero impact on the fiscal note for these agencies.

Officials from the **Missouri Senate** state they anticipate a negative fiscal impact to reimburse 2 Senators for travel to Juvenile Justice and Education Task Force meetings. In summary, it will cost approximately \$335.36 per meeting.

Officials from the **Office of the State Courts Administrator** state there may be some impact but there is no way to quantify that currently. Any significant changes will be reflected in future budget requests.

Officials from the **Office of the Secretary of State (SOS)** note many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$5,000. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with its core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

Officials from the Attorney General's Office did not respond to our request for fiscal impact.

**Oversight** notes the new Task Force on Juvenile Justice and Education is comprised of seven (7) members. Oversight notes subsection 211.575.8 states the members shall serve without compensation and shall not be reimbursed for their expenses. Oversight notes subsection 211.575.10 states the task force shall submit a report on their findings to the Governor and the General Assembly by December 31, 2024. Oversight assumes the proposal will not have a material fiscal impact on the state.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION

The proposed legislation appears to have no direct fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
