FISCAL ANALYSIS

ASSUMPTION

§292.606 – Fees collected by the Missouri Emergency Response Commission

Officials from the **Department of Public Safety (DPS)** – **State Emergency Management Agency (SEMA)** state currently, the collection of fees for hazardous chemicals in the workplace, which funds the Missouri Emergency Response Commission (MERC), is authorized until August 28, 2024. This would extend the authorization for six years to August 28, 2030.

The mission of the MERC is to protect public health and the environment by assisting communities with chemical incident prevention, preparedness, response, and recovery; and by receiving, processing, and reporting on chemical information under the community right-to-know laws. The program has been in existence since the late 1980s and has provided training and assistance to local communities to be compliant with the federal EPCRA (Emergency Planning and Community Right-to-Know Act) laws. Current law allows for the collection of data and fees.

In fiscal year 2023, the amount collected was approximately \$957,000 with 65% of this fund being redistributed to the locals, 10% distributed to the Missouri Division of Fire Safety for hazardous materials training and the remaining 25% is retained by the MERC to operate the program and to provide a match for federal funds that allow additional hazardous materials planning and training for local first responders. The chemical storage facility owners and gas station owners must pay the annual fee based on the type and amount of chemicals they store at their facility.

If not renewed, the Local Emergency Planning Committees or Districts would lose approximately \$650,000 in eligible funds. In many communities, these are the only funds available to remain compliant with federal law and most preparedness activities will not continue. Approximately \$80,000 in training money to the Missouri Division of Fire Safety would be lost, and the match for the \$400,000 dollars for the Missouri Department of Transportation grant would not be met. Without this grant, approximately 1,000 first responders will not receive any hazmat preparedness or response training.

Oversight notes receipts into the Chemical Emergency Preparedness Fund averaged \$835,640 per year during the period FY 2020 – FY 2023; disbursements averaged \$676,538 (81% of total receipts) during the same period.

Oversight will present \$957,000 in fees collected annually to the Chemical Emergency Preparedness Fund by SEMA for MERC. These fees will continue to be collected until August 28, 2030. Oversight notes, with the exception of approximately 25% retained in the fund by MERC, funds are distributed to local emergency planning committees, the DPS - Division of Fire Safety and the Missouri Department of Conservation for hazardous materials training and assistance. Oversight will reflect ten months of impact in FY 2025.

Officials from the Department of Commerce and Insurance, the Department of Economic Development, the Department of Health and Senior Services, the Department of Natural Resources, the DPS – Division of Fire Safety and the Director's Office, the Office of the Governor, the Kansas City Police Department and the St. Louis County Police Department each assume the proposal will have no fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Oversight only reflects the responses received from state agencies and political subdivisions; however, other cities, various county officials, sheriffs' and police departments and fire protection districts were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.
