FISCAL ANALYSIS

ASSUMPTION

§208.152 - MO HealthNet coverage of hearing aids and cochlear implants

The MO HealthNet Division (MHD) identified 224,154 adults who are currently enrolled in MHD Fee-for-Service could be eligible for hearing aid services. MHD estimates that 7.1% (15,915) of those adults may utilize these services. The average cost of hearing aid services is \$210.73.

This legislation would also result in an impact to the Managed Care capitation rates of up to \$10 million. The cost of the actuarial study to evaluate this program change would be no more than \$25,000 in the first year.

Due to the timing of obtaining a SPA and waiver for this legislation, MHD assumes additional costs for hearing aid services will begin in FY26. MHD estimates 80% of the participants identified will obtain hearing aid services in the first year due to pent-up demand, and 20% in subsequent years. A 6.3% medical inflation rate was used for FY27.
