FISCAL ANALYSIS

ASSUMPTION

Officials from the **State Tax Commission** assume the proposal will have no fiscal impact on their organization. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note.

Oversight only reflects the responses received from state agencies and political subdivisions; however, other counties, county recorders, county collectors and county treasurers were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.

Oversight assumes this proposal modifies the section requiring notices of county planning board hearings be posted on the county’s website and repeals the notices to be posted at least 15 days in advance of the hearing in at least two places in each township. Oversight assumes this modification to the section will have no fiscal impact on this proposal.


