FISCAL ANALYSIS

ASSUMPTION

§173.1541 – Funding for higher education

Officials from the **Department of Higher Education and Workforce Development (DHEWD)**, the **University of Central Missouri** and the **Missouri House of Representatives** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Officials from **Northwest Missouri State University (NWMSU)** state this proposal has the potential for a positive fiscal impact on NWMSU dependent on the model and approval.

Oversight assumes colleges and universities will have no direct fiscal impact as a result of this legislation as the proposal directs that a funding model be developed. Any impact experienced by institutions of higher education is dependent on the adoption of a new funding model and funding of that model by the General Assembly.

Oversight notes, in the 2022 legislation session, the General Assembly passed HB 3003 which directed the DHEWD to commission a study that would provide recommendations to the Governor and the General Assembly on higher education performance funding models. DHEWD contracted with the National Center for Higher Education Management Systems (NCHEMS) to conduct a review of the State’s higher education funding models and create a recommended funding model for the state of Missouri. In addition, NCHEMS was to review efficiency measures. NCHEMS issued their final report with the results of their review of Missouri’s higher education performance funding models along with recommendations on July 3, 2023. Based on their findings, the NCHEMS designed a new funding model for Missouri institutions of higher education

No direct fiscal impact to small businesses would be expected as a result of this proposal.

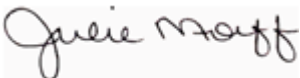
FISCAL DESCRIPTION

The proposed legislation appears to have no direct fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
