§307.175 – Adds to list of vehicles that may display emergency lights and sirens

Officials from the **Department of Revenue**, the **Department of Public Safety – Division of Fire Safety** and the **Missouri Highway Patrol**, the **Missouri Department of Transportation**, the **Phelps County Sheriff's Department**, the **Kansas City Police Department** and the **St. Louis County Police Department** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Oversight only reflects the responses received from state agencies and political subdivisions; however, other sheriffs and police departments were requested to respond to this proposed legislation but did not.
