FISCAL ANALYSIS

ASSUMPTION

Section 227.861

Officials from the **Missouri Department of Transportation (MoDOT)** state HB 2639 is estimated to have a total negative impact on the State Road Fund of \$4,000. This would be a one-time expense as the language requires MoDOT to fund this designation with no costs for sign fabrication and installation recouped through the participation fee. The estimated cost is \$2,000 per sign, with 2 total signs for this designation.

Oversight has no information to the contrary. Therefore, Oversight will present the fiscal impact of this proposal as provided by MoDOT.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
