FISCAL ANALYSIS

ASSUMPTION

§210.499 - Office of State Oversight for Residential Care Facilities

Officials from the **Department of Social Services (DSS)** state as follows:

The DSS Director's Office will require one (1) Division Director (\$139,008 annual salary) and two (2) Senior Regulatory Auditors (\$67,274 annual salary each) to encompass the added duties related to this legislation.

The DSS Division of Legal Services (DLS) states this proposed legislation creates new administrative oversight for residential care facilities licensed by DSS or DHSS. This new admin oversight would be via a newly established Office of State Oversight for Residential Care Facilities within the Department of Social Services. There is an anticipated fiscal impact for the Division of Legal Services (DLS) in that the new Office of State Oversight for Residential Care Facilities would require promulgation of regulations and policy, as well as continued legal support as the Office carries out their responsibilities of conducting investigations, inspections and reviews, as well as publishing required summaries and other materials. This legislation increases the need for DLS services and would require one (1) additional special counsel (\$89,172 annual salary) and one (1) additional legal assistant (\$45,823 annual salary).

Oversight does not have information to the contrary and therefore, Oversight will reflect the estimates as provided by the DSS.

Officials from the **Office of the Governor** state this bill adds to the Governor's current load of appointment duties. Individually, additional requirements should not fiscally impact the Office of the Governor. However, the cumulative impact of additional appointment duties across all enacted legislation may require additional resources for the Office of the Governor.

Oversight does not have any information to the contrary. Therefore, Oversight assumes the Office of the Governor will be able to perform any additional duties required by this proposal with current staff and resources and will reflect no fiscal impact to the Office of the Governor for fiscal note purposes.

Officials from the Department of Elementary and Secondary Education, the Department of Health and Senior Services, the Department of Mental Health, the Department of Public Safety – Division of Fire Safety, the Missouri Senate, the Office of Administration and the Newton County Health Department each assume the proposal will have no fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Oversight only reflects the responses received from state agencies and political subdivisions; however, other local public health agencies and fire protection districts were requested to respond to this proposed legislation but did not. FISCAL IMPACT – Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

This bill establishes within the Department of Social Services the "Office of State Oversight for Residential Care Facilities" for the purposes of assessing facility compliance with laws, rules, and regulations of the Federal and State governments. The Office is administered by a director, appointed by the Governor, who serves a term of six years and who can not be related to current

or former employee or contractor of a residential care facility or of the Children's Division within the Department, as specified in the bill.

This bill also specifies provisions for what information is required to be included in inspection reports for all residential care facilities. The Office is also required to review procedures of the Children's Division to determine if such procedures are adequate as they relate to complaints made by or on behalf of a child. For this review process, the bill establishes parameters for the authority granted to the Office. Upon completion of such a review, the Office is required to submit and make public a report, which must also be delivered to the Governor, the Attorney General, and both houses of the General Assembly. This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements, but would require rental space.
