## **FISCAL ANALYSIS**

#### **ASSUMPTION**

Officials from **Missouri Department of Transportation (MoDOT)** state this bill is estimated to have a negative impact on the State Road Fund of \$4,000 for each of the 19 memorial designations funded by MoDOT, for a total of \$76,000 (19 x \$4,000). This would be a one-time expense as the language requires MoDOT to fund these designations with no costs for sign fabrication and installation recouped through participation fees. The estimated cost is \$2,000 per sign, with 2 total signs for each designation.

There are three memorial designations in this legislation that will be funded by private donation and would have no impact to the State Road Fund.

**Oversight** has no information to the contrary. Therefore, Oversight will present the fiscal impact of this proposal as provided by MoDOT.
