**FISCAL ANALYSIS**

**ASSUMPTION**

**§334.038 - Program to increase the number of medical clinics in medically underserved areas**

Officials from the **Department of Health and Senior Services (DHSS)** state DHSS has not been able to find any grants that this proposal would be applicable to. Currently, this fund has not been appropriated any funds; therefore, at this time DHSS considers this proposal to have no fiscal impact.

**Oversight** notes the Office of the State Treasurer (STO) fund description states the Medical Clinics in Medically Underserved Areas Fund (0265), “Shall consist of moneys appropriated, gifts, grants, donations, or any other contribution from any source. Moneys shall be used solely to increase the number of medical clinics in medically underserved areas.” The initial fund authorization became effective August 28, 2014 under SB 716 and SB 754. According to the STO’s fiscal year fund reports, there has been no activity in the fund going back to 2015.

Officials from the **Department of Commerce and Insurance** assume the proposal will have no fiscal impact on their organization. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION

The proposed legislation appears to have no direct fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
