FISCAL ANALYSIS

ASSUMPTION

Section 386.050 – Public Service Commission

Officials from the **Department of Commerce and Insurance (DCI)** – **Public Service Commission (PSC)** state this proposal changes the commission from 5 members to 7 members. This would result in an additional 2 Commission Members (each at \$132,345 annually), 2 Program Consultant/Advisors (each at \$101,202 annually) and 1 Administrative Assistant (at \$59,920 annually) for a total of 5 additional FTE and at cost of \$736,124 in FY 2025, \$847,061 in FY 2026 and \$862,501 in FY 2027 to provide for the implementations of change in this proposal.

Oversight does not have any information to the contrary. Therefore, Oversight will reflect the cost estimate as provided by DCI-PSC.

Officials from the **Office of the Governor** and the **Missouri Senate** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

FISCAL IMPACT – Small Business

FISCAL DESCRIPTION

This act provides that the Public Service Commission shall consist of seven members, instead of five members, provided that no more than one member shall be appointed from each congressional district. At least two members shall be actively engaged in production agriculture, as defined in the act.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
