AN ACT

To appropriate money for real property leases, related services, utilities, systems furniture, structural modifications, and related expenses for the several departments of state government and the divisions and programs thereof to be expended only as provided in Article IV, Section 28 of the Constitution of Missouri, and to appropriate money for capital improvements and the other expenses of the Office of Administration and the divisions and programs thereof, and to transfer money among certain funds for the period beginning July 1, 2024, and ending June 30, 2025.

Be it enacted by the General Assembly of the state of Missouri, as follows:

- 1 There is appropriated out of the State Treasury, to be expended only as provided in 2 Article IV, Section 28 of the Constitution of Missouri, for the purpose of funding each 3 department, division, agency, and program enumerated in each section for the item or items 4 stated, and for no other purpose whatsoever chargeable to the fund designated for the period 5 beginning July 1, 2024, and ending June 30, 2025 as follows:
- 1 Section 13.005. To the Office of Administration
- 2 For the Division of Facilities Management, Design and Construction

3 For the payment of real property leases, operation of state-owned

- 4 facilities, operation of institutional facilities, utilities, systems
- 5 furniture, and structural modifications, provided that five percent
- 6 (5%) flexibility is allowed between and within departments, and
- 7 one hundred percent (100%) between federal funds within this
- 8 section, and further provided three percent (3%) flexibility is
- 9 allowed from this section to Section 13.015
