AN ACT

To repeal sections 442.560 and 442.571, RSMo, and to enact in lieu thereof two new sections relating to foreign ownership of real estate.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Sections 442.560 and 442.571, RSMo, are repealed and two new sections 2 enacted in lieu thereof, to be known as sections 442.560 and 442.571, to read as follows:

442.560. Except as provided in sections 442.560 to 442.591, beginning August 28, 2 2024, persons not citizens of the United States and not residents of the United States or of 3 some territory, trusteeship, or protectorate of the United States, and corporations not created 4 by or under the laws of the United States or of some state, territory, trusteeship, or 5 protectorate of the United States shall be capable of acquiring, by grant, purchase, devise or 6 descent, real estate except agricultural land as defined in section 442.566, or any interest therein, in this state, and of owning, holding, devising, or alienating the same, except those 7 persons not citizens of the United States and not residents of the United States or of 8 9 some territory, trusteeship, or protectorate of the United States, and corporations not 10 created by or under the laws of the United States or of some state, territory, trusteeship, or protectorate of the United States that have acquired real estate in this state prior to 11 August 28, 2024, shall continue to own and hold the acquired real estate and shall incur 12 13 the like duties and liabilities in relation thereto as if they were citizens of the United States 14 and residents of this state, but shall not grant, sell, or otherwise transfer such real estate 15 on or after August 28, 2024, to any other person not a citizen of the United States and 16 not a resident of the United States or of some territory, trusteeship, or protectorate of 17 the United States, nor to a corporation not created by or under the laws of the United

- 20 counties which border the state of Oklahoma which was owned by such a person described in
- 21 this section prior to January 1, 1995.]

442.571. 1. Except as provided in sections 442.586 and 442.591, [no alien or foreign business shall acquire by grant, purchase, devise, descent or otherwise agricultural land in this 2 state if the total aggregate alien and foreign ownership of agricultural acreage in this state 3 exceeds one percent of the total aggregate agricultural acreage in this state. A sale or transfer 4 of any agricultural land in this state shall be submitted to the director of the department of 5 agriculture for review in accordance with subsection 3 of this section only if there is no 6 completed Internal Revenue Service Form W-9 signed by the purchaser] beginning August 7 28, 2024, no alien or foreign business shall acquire by grant, purchase, devise, descent, 8 or otherwise any agricultural land in this state. Any alien or foreign business who 9 10 acquired any agricultural land in this state prior to August 28, 2024, shall not grant, sell, or otherwise transfer such agricultural land to any other alien or foreign business on or 11 12 after August 28, 2024. No person may hold agricultural land as an agent, trustee, or other 13 fiduciary for an alien or foreign business in violation of sections 442.560 to 442.592, 14 provided, however, that no security interest in such agricultural land shall be divested or invalidated by such violation. 15

2. Any alien or foreign business who acquires agricultural land in violation of sections 442.560 to 442.592 remains in violation of sections 442.560 to 442.592 for as long as [he or she] the alien or foreign business holds an interest in the land, provided, however, that no security interest in such agricultural land shall be divested or invalidated by such violation.

20 3. Subject to the provisions of subsection 1 of this section, [such] all proposed [acquisitions] transfers on or after August 28, 2024, by grant, purchase, devise, descent, or 21 otherwise of any interest in agricultural land held by any alien or foreign business in this 22 23 state shall be submitted to the department of agriculture to determine whether such 24 [acquisition] transfer of agricultural land is conveyed in accordance with the [one percent 25 restriction on the total aggregate] prohibition on alien and foreign ownership of agricultural land in this state under this section. The department shall establish by rule the requirements 26 for submission and approval of requests under this subsection. 27

4. Any rule or portion of a rule, as that term is defined in section 536.010, that is created under the authority delegated in this section shall become effective only if it complies with and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section and chapter 536 are nonseverable and if any of the powers vested with the general assembly pursuant to chapter 536 to review, to delay the effective date, or to disapprove and annul a rule are subsequently held unconstitutional, then the grant of HB 2928
