Good morning, thank you to the Chair and committee for having me today. My name is Madeleine Roberts, I am here today with MOST Policy Initiative. We provide research resources to the Missouri State Legislature, and I am here today to share the information contained in our science note, Catalytic Converter Theft. Catalytic converters are the target of theft because they contain valuable metals, lack distinguishing features such as a VIN number, and are easy to remove from a vehicle and sell. Recyclers typically pay \$50-250 for each catalytic converter, and catalytic converters can be sold on the black market for up to \$1000. A replacement catalytic converter can cost the owner \$1000-4000, which is covered by a drivers' comprehensive insurance coverage. 32 states passed laws addressing the theft of catalytic converters in 2021-2022 by different strategies. Some states require specific record keeping in the buying and selling of catalytic converters, attaching VIN numbers to a vehicle's catalytic converter, and some states have attached felony charges to catalytic converter theft. The efficacy in reducing theft by these methods has not yet been studied due to their recency.
