I am Opposed to this Bill and Proposed Change and Decrease in Mileage triggering and Requiring a "Safety-Inspection" of a vehicle. By an Amendment offered, I believe that this Bill Requires a State Safety Inspection on any Vehicle that is more than three (3) Years old and over 40,000 Miles.
