The Missouri Insurance Coalition is unable to attend this hearing due to a previously scheduled member meeting. We have had discussions with the bill sponsor regarding some members concerns that the broadness of the bill's language could inadvertently interfere with their use of telematics under the consent of a vehicle owner or insured. We will work with the bill sponsor and provide him with language to address the concerns.
