My children and I have never experienced discrimination based on our hair, and the thought of anyone experiencing this in the year 2024 is astonishing. While hair discrimination impacts both men and women, it tends to target Black women more often. There are over 160,294 Black women workers in Missouri alone who are vulnerable to this unethical discrimination. There are also countless examples of children being removed from classrooms and even schools due to their natural hair. No child should have to carry this				

worry with them when they're walking into the place where we're tasked with making them feel safe and welcome. It's long past time for Missouri to join the 24 other states that have put protections into place against hair-based discrimination. I am extremely grateful for the bill sponsor and all that myself and my children have learned from listening to them advocate for this legislation. Thank you for that, Representative Bosley. I strongly urge the committee to vote in favor of House Bill 1591.

Associated Industries of Missouri opposes the bill because section 213.012 of the bill attempts to				

include hair texture and protective hairstyles in the definition of "race" for purposes of the Mo. Human Rights Act. This will allow people that are not minorities to claim protection based on their hairstyles. Courts have held that discrimination cases may be brought by non-minorities (McDonald v. Santa Fe Trail Transportation Co., 427 U.S. 273 (1976)) If this section is removed, we would have no opposition to the bill.
