Dear Honorable Representatives, This is long overdue. I am a former school teacher in Cass County and currently on the school board of a K-8 very small school district. The school develops a budget that is not based on "need", but on "wants". Last August, I educated the board that we would need to adjust the levy lower if we didn't want to increase landowners' taxes (since the property reassessment took place). As a result, they chose to apply the MAXIMUM ALLOWABLE CEILING rate like they have every year for many years. This school has only 120 students and my tax to the school over \$1800 a year. I have no teacher retirement. The \$1800 is almost three months of my social security!!! Those of us who question the taxes are considered anti-child. Not so! Please adjust the ceiling tax rates; and more than 2%. We're really struggling and the economy is not looking good long term. Sincerely,
