While I have no objection to the evident intent of this bill, I suggest that the language be amended so as to clarify that it applies only to signage erected by MODOT. As it stands, the bill text could be construed as applying to signage erected by a private party: "...or permit any signage in the convicted person's memory." While such signage may be offensive and deplorable, it would fall squarely within the protection of the First Amendment. Perhaps, for example, it would suffice to change "permit" to "erect" in the above snippet.
