We support the changes to Sections 491.075 and 492.304 regarding admissibility of children's statements under Chapters 565, 566, 568 or 573. Theses changes passed the House in 2023 but died in the Senate when an unrelated matter was added to the original bill. We also support the changes in 566.151 and 567.030. Finally, the change in 595.045 is needed to add class E felonies to payments to the Crime Victims' Compensation Fund. The failure to add class E felonies was an oversight when the criminal code revision was passed and class E felonies created.
