Dear Committee, Thank you for the opportunity to submit my support of HB1918. I am the current Director of the Missouri Commission for the Deaf and Hard of Hearing. While we currently run a program to assist low-income families with the purchasing of hearing aids, we are only able to assist approximately 35-40 people a year. We are often restrained by rules of our program funding leaving people to find assistance elsewhere or to reapply for the next cycle. Adding hearing aids under Mo HealthNet would allow for many individuals new to hearing loss or experiencing late onset of hearing loss an easier way access devices that would have significant impact on their daily lives.

As an audiologist, I am deeply concerned about the accessibility to life-changing hearing devices for persons with hearing loss in state of Missouri. As you may know, hearing aids and implantable hearing devices (cochlear implants and bone conduction implants) are used to help those with hearing loss. These devices are not a covered benefit for adult MO Healthnet beneficiaries in the state of Missouri which has created an inequity in access to these vital technologies among the most vulnerable of our population. HB1918 currently being considered by the Missouri General Assembly addresses this access issue by expanding coverage for hearing devices to adult Medicaid beneficiaries. I am writing to ask that you support this legislation. I am happy to relay stories and experiences from patients where hearing technology such as the cochlear implant has significantly impacted their lives.

I am very grateful for a left ear Cl in year 2022 and a right ear Cl in 2023 thanks to Medicare. I had difficulty in school hearing, answering questions correctly, and socially due to my hearing loss. I was 19 in college before people around me mentioned my hearing loss. It's very unfortunate children are hearing impaired when learning language and to read! My husband, children, and friends became my interpreter when I missed what was said. After writing notes at our family Thanksgiving gathering in 2021, I decided it was finally time to get a Cl. I was hearing maybe 10 percent with hearing aids, now with Cls, maybe 50-60 percent and hopefully better after audio rehab and another mapping.

My name is Joshua M. Sappington, MD and I am a neurotologist and lateral skull base specialist at Saint Louis University School of Medicine. My career and practice is dedicated to caring for patients with hearing loss. The current gap in hearing restoration coverage for Missouri residents on Missouri Medicaid is something that needs to be addressed immediately. Individuals over the age of 21 with hearing loss face significant challenges secondary to their medical condition. They are not able to interact with their world around them leading to an inability to work, decreased compensation at work, decreased quality of life and potential neurocognitive decline later in life. To make it simple if a person cannot hear and cannot communicate efficiently they will not maximize their potential compensation and/or cannot work. This has long ranging implications for the individual patient with their finances and retirement, the local and state economy as individuals will work lower paying jobs or not at all. Patients who are unable to work face economic hardship and the potential of being on disability which is far more expensive than a hearing restoration device. To further compound this hearing loss is a life long disease which is progressive in nature. Unfortunately, patients will not improve their hearing as they age which means that the hearing patients have today is the best hearing they will have the rest of their life. Missouri residents who need services for hearing aids, cochlear implantation, or osteointegrated implants have a critical medical need that we need to address. I fully support expansion of hearing devices for all Missouri Medicaid adults over 21 as a hearing specialist, someone who has battled hearing loss personally, and has a family member who has received cochlear implantation. Thank you for your consideration.

February 12, 2024To: **Chairman Haden and Members, House Healthcare ReformFrom:** Date: Mallory Rusch, Executive Director, Empower MissouriRE: Our support for HB 1918 and HB 2626Empower Missouri has spent more than 120 years fighting poverty in Missouri. Today, we come to present testimony on a bill which specifically targets our neighbors with the lowest incomes. On behalf of our staff, board, and coalition members we are asking you to support HB 1918 and HB 2626. Hearing aids and cochlear implants are critical resources for individuals with hearing impairment or a full loss of hearing. According to the Hearing Industries Association, the average cost of prescription hearing aids ranges between \$1,000 and \$4,000, depending on the severity of the hearing loss. In Missouri, the income cap for individuals receiving healthcare through MO HealthNet is \$19,392. The income cap for a family of four is \$39.900. I would implore this committee to consider your own families' annual income and expenses, and then consider if you feel like an individual or family earning this low of an income could manage to afford a \$2,500 medical bill just to be able to hear. If this issue is debated the way that I've seen similar issues debated in this committee, I'm sure that lobbyists for the health insurance industry will tell you that when you add additional services, like hearing aids, to healthcare plans, the prices will go up for everyone on those plans. That may be the case, but that is a choice made by the health insurance industry. Meanwhile, CEOs of major healthcare companies like Anthem, Aetna and United Healthcare are raking in between \$15M and \$25M annually in salaries, bonuses, and stock options. This is simply another case of forcing those with the least among us to beg for basic necessities while the rich get richer. As a taxpayer whose tax dollars go to fund programs like Medicaid, I want those funds to ensure that families covered by Medicaid aren't just surviving, but thriving. I know that there are many, many other Missourians who agree with me. The ability to hear is necessary to thrive. Please vote "do pass" on these bills.

I am a practicing Otolaryngologist subspecialized in Otology and Neurotology (ear and skull base surgery) serving in Springfield, MO. Our practice (and organization - Mercy) is one of a few committed to caring for the underserved in our region. I help provide medical and surgical care for adult and pediatric Medicaid patients that do or would benefit significantly from hearing devices (hearing aids and cochlear implantation). At this pint, I am the only Otolaryngologist in the region (South Missouri) performing these necessary services. Currently there is no hearing aid or Cochlear Implant coverage for adults on Missouri Medicaid over the age of 21 unless they are blind, pregnant, or in a long-term care facility. Despite my organization's commitment to providing care for these patients, they are being denied access to critical healthcare which directly affects their ability to maintain employment and communicate. Expansion of coverage in this area would help these patients obtain critical hearing health services. This would allow many of them to maintain or obtain employment and significantly improve their quality of life in a large majority of cases.

We ask that you support HB. 1918 which restores coverage for cochlear implants and hearing aids for adults under Missouri Medicaid. With passage of the bill, Missouri would join the majority of States that offer this lifechanging intervention for adults. Cochlear implantation is a well-known and established procedure that has been approved by the FDA for use in adults since 1985 and in children since 1990. Cochlear implants play a critical role in restoring the ability to perceive speech and environmental sounds for appropriate individuals with moderate to profound hearing loss who do not benefit sufficiently from hearing aids because of the severity of their deafness. Cochlear implants allow recipients to communicate freely including participating in the workforce, caring for themselves and family members, and enjoying important quality of life improvements. Without intervention with appropriate hearing assistive technology, adults with untreated or undertreated hearing loss may experience a downward trajectory in quality of life. Not only does it impact communication and socialization, hearing loss also has comorbidities which increase chance of falls and dementia. The financial impact of adult hearing loss is growing. In 2002, lost productivity attributed to hearing loss was \$1.4 billion; this is expected to grow to \$9 billion by 2030 (Stucky, Wolf & Kuo, 2010). By providing hearing intervention for adults, your state will be able to mitigate some of this loss. This coverage will also benefit those who were implanted as children under Medicaid and transition at age 21. When a state Medicaid program does not cover cochlear implantation for adults, it can mean a person loses access to sound when their processer becomes obsolete or is damaged. Many of those young adults are still in school or getting started in their work life and do not yet have private insurance. Please support Hb 1918 for continued support of access to cochlear implantation. I am happy to answer any further questions. I am testifying in favor of House Bill 1918 to increase coverage for adults with Medicaid to include hearing aids and cochlear implants. I am an audiologist practicing in Osage Beach and provide many hearing health services in our beautiful, rural, lake community. Everyday I evaluate adults with Medicaid, and these evaluations frequently result in a recommendation to obtain hearing aids and/or cochlear implants. I am often faced with a very uncomfortable conversation when I tell my adult patient that their Medicaid insurance does not provide any coverage for hearing technology. The cost to obtain hearing aids, let alone cochlear implants, is outside the realm of possibility for nearly all of my Medicaid patients. I cannot recall off the top of my head any adult patient with Medicaid who moved forward to obtain hearing aids. Lack of coverage for hearing technology ends up costing our healthcare system more money. A 2018 study from Johns Hopkins Bloomberg School of Public Health found that over a ten year span, untreated hearing loss in older adults resulted in 46% higher healthcare costs compared to those with treated hearing loss. In some cases, the savings could be further compounded: according to a national survey, compared to adults with treated hearing loss, adults with untreated hearing loss make \$12,000 less annually; furthermore, those with severe untreated hearing loss have an unemployment rate that is twice as high. Providing treatment for adults with hearing loss may result in higher employment rates, and in turn, these individuals would have access to employer provided health insurance and no longer need Medicaid. Expanding adult Medicaid coverage to include hearing aids and cochlear implants would save money for the healthcare system. I strongly favor House Bill 1918 and look forward to expanded coverage for adults with Medicaid needing hearing aids and cochlear implants. Sincerely, Stephanie TittleDoctor of Audiology
