My name is Carly Overesch and I am a second grade teacher in Kansas City Public Schools. During the 2022-2023 school year I was able to participate in the Teacher Externship program at University Health. KCPS partnered with UH to pilot the program for the district. I was able to work with two other teachers from the district; a science and technology teacher from Lincoln Preparatory Academy and a health sciences teacher from Manual Career and Technical Institute. During our time at UH we had 16 rotations. We shadowed UH staff, met with patients, had hands-on experiences, and assisted employees with their daily tasks. We were able to learn from people with different backgrounds and levels of education. We were given opportunities to ask questions about their personal lives and what brought them to their current roles, as well as the ins and outs of their current work loads. While we were learning from employees in departments from Radiology to Environmental Services to Food Services to Public Safety, we were able to see a broad range of opportunities offered for all in the health care facilities. Teaching in the urban core of Kansas City has made me realize that many of our students don't know how many opportunities there are for them right in their own city. Opportunities that provide a stable income, benefits, and the fulfillment of helping others. Many of our students have very little knowledge of the jobs offered in health services. When I asked my students what job they could have if they worked in the hospital, they all answered with "nurse or doctor". I had a blast being able to share with my students the roles they could potentially take on and the opportunities they all can have! At KCPS, we pride ourselves on making sure our students are "career ready", we know that not every student makes plans for college. Through this externship, we were able to share with students the careers they could have at UH with just a high school diploma. This externship was enlightening and invaluable in that I returned to my classroom able to inform and excite my students about potential future opportunities.

Bringing something like this to the high school level would be an educational game changer for us here at Notre Dame.
