Tangible assets are much more durable than printed Federal Reserve Notes or the Central Bank Digital Currency that the Federal Reserve is working to implement. By making gold and silver more accessible to the average person, Missourians would be able to secure their own financial situation and gold and silver as legal tender would provide a great option to hedge against inflation and the possible collapse of the US Dollar. Many other states have either already recognized gold and silver as legal tender or are working to pass similar legislation. We do not want Missouri to be left behind. There are reports that many foreign countries have started to hoard gold and silver, so delaying recognition of gold and silver as legal tender is putting Missourians at a disadvantage. I am concerned that when the Federal Reserve implements Central Bank Digital Currency it will allow the United States to start down the slippery slope of social credit scores. China has an oppressive “social credit score” system and it is common practice there to limit access to funds or even disable a person's bank account when they express opinions counter to the CCP. Placing control of all currency into one centralized system governed by bureaucratic officials not beholden to the citizens of our country is very dangerous to our freedom in the United States. The United States Constitution already defines gold and silver as legal tender. Missouri’s recognition of gold and silver as legal tender is an important step in providing options outside of the Central Bank Digital Currency. I want my children, grandchildren, and great-grandchildren to have the opportunity to make a living and a life here in the state of Missouri and recognizing gold and silver as legal tender will help secure that opportunity.
