prisoners, reimbursed at the state rate.10 or so are Federal prisoners, reimbursed at \$70 / day.Actual cost is about \$68 per day.At the current reimbursement rate, Marion County is losing about 40% of the cost, in addition to the cost of money from delays in reimbursement.The raise in reimbursement is sorely needed.
