My name is Danielle Campbell. I grew up in Grain Valley, MO with my mom and dad. My grandparents lived down the road and we visited them often. I was on the Honor Roll and actively involved in sports. In 2016, I ended up in prison on a possession charge. My felony should not define me. If I had a 'clean slate' this could eliminate barriers that I continue to face even though I have served my time in the Missouri Department of Corrections. I am now a case manager at Journey to New Life, helping other men and women who are released from prison. I support my clients with reentry life skills, housing support, advocacy, financial literacy, amongst other things. Currently in Missouri the expungement process is expensive and difficult to navigate, shutting out people with low incomes who already qualify for a second chance. Under our current system, those with money or powerful connections are treated differently than everyone else. If we can automate the process, it will even the playing field for everyone. I make 45k per year and things are very tight with paying \$900 in rent, \$100 for utilities, \$100 for food, a \$500 car payment, \$150 for insurance and \$30 intervention fees, just to name a few. If it weren't for Journey to New Life, I wouldn't come close to making a livable wage. Like so many of my peers, we are not being given opportunities to be successful. Employers are defining who we are based off our past and not willing to hear the strives we've made to better our lives. This is also the case with landlords, I was denied housing through multiple properties from a felony possession charge I originally got in 2011. Clean Slate offers someone like me a life that would not be defined by their worst mistake, and those who have completed their sentence and stayed out of trouble with the law deserve a second chance. I have paid my debt to society and should not be punished forever by being denied jobs, housing, and the opportunity to be an active member of my community.

Testimony Missouri State House of Representatives General Laws Committee Public Hearing on HB 2108 and HB 2555, Clean Slate Testimony by David Bowser, Deputy Director of Legislative Affairs Faith & Freedom Coalition March 26, 2024 Thank you, members of the General Laws Committee, for the opportunity to provide electronic testimony today. My name is David Bowser and I am Deputy Director of Legislative Affairs for the Faith & Freedom Coalition. On behalf of our 2.5 million members and supporters nationwide, thank you for considering HB 2108 offered by Representative Christofanelli and HB 2555 offered by Representative Hicks, we urge you to quickly and favorably report them out of the General Laws Committee for consideration by the full House. This legislation will reduce recidivism, increase employment, strengthen families and communities, and provide a pathway to redemption for those who want to reform their lives. No one would deny that crime should be punished; but punishment should not continue in perpetuity. Those who have paid their debt to society for low-level or non-violent offenses and who have reformed their lives deserve to be given a second chance and fully welcomed back into society. Rehabilitation is the goal of the criminal justice system. We want offenders to pay their debts and to amend their lives. Those who do, should be rewarded, and restored to society—for their good, their families’ benefit, and for the betterment of our communities. Collectively, these bills would provide a pathway for those convicted of lower-level offenses, who have served their full sentences, returned to society, remained crime-free, and are eligible for electronic expungement receive this life changing opportunity automatically. The opportunities Clean Slate provides to encourage returning citizens to live a crime-free life have been successful in the states where it has already been implemented, including the original effort in Pennsylvania (2018) and its expansion (2023), as well as Utah (2019), Michigan (2020), Oklahoma (2022), and Colorado (2022) among others. We expect this number to continue to grow in the next few years and would urge Missouri to be next on this list. The practical, real-world benefits of Clean Slate are well documented as expungement of electronic records for lower-level offenders provide for: • Increase in the workforce, including many skilled workers. • Employment opportunities with better wages and benefits. • Stronger credit ratings. • Better and safer housing options. • More stable families and safer communities. • Significant incentives to remain crime-free. While these benefits are substantive, HB 2108 and HB 2555 ensures these efforts remain targeted to the penalties and timeframes that research has demonstrated to be safe and effective. Drug trafficking, serious violent, sexual, and gun-related crimes are excluded from automated sealing and law enforcement can still see the sealed records. HB 2108 and HB 2555 are carefully drafted to target those persons who have demonstrated over a long period of time that they are crime-free. The goal is to help them attain employment, strengthen credit ratings, and secure housing. Nearly one in three Americans now have

some type of criminal record, which reduces their chances of getting a callback or job offer by nearly 50 percent and makes it much harder to find housing. This is at a time when the Bureau of Labor Statistics nonfarm payrolls report consistently low unemployment rates and that businesses, especially small and family-owned businesses, are having a difficult time filling job openings. This is reflected by the eight Missouri Chambers of Commerce, MOKAN (Missouri, Kansas, and Arkansas Economic Development Association), the Small Business Majority, and the numerous employers across Missouri who have all come out in support of this legislation. Providing individuals with a second chance at redemption—and an opportunity to earn an honest living and provide for their families—is core to our values. This is why we urge you to quickly and favorably report HB 2108 and HB 2555 out of this committee to the full House. Missouri Appleseed submits this written testimony in support of Rep Christofanelli's HB 2108 and Rep Hicks' HB 2555, the Clean Slate Bills. Missouri Appleseed believes all Missouri families deserve the opportunity to thrive. The Clean Slate Bills align with Missouri Appleseed's mission. Currently, Missouri law allows for persons with a criminal record to apply for expungement, with exceptions carved out for certain crimes which cannot be expunged. However, the vast majority of those eligible for expungement cannot utilize this right due to the disproportionate economic burden associated with the expungement process. Specifically, only those who can afford the expungement process are able to access this statutory right, while those who cannot afford it are not able to have their eligible record expunged. The Clean Slate bills create an automated process for expungement giving all who are eligible access to the right to have their criminal record expunged. In addition, the Clean Slate bills will help put an end to the cycle of poverty which results from the barriers that Missourians with a criminal record face upon reentering society. Expungement creates better employment opportunities, affordable housing options, and more opportunities for education that lead to better life outcomes for those directly impacted, as well as their children and families. Moreover, it can boost the economy, having a positive impact of an estimated \$2.9 billion in annual economic activity and \$131 million in general revenue, due to the increase in employment and access to jobs with higher wages. Increasing access to expungement through automating the process will also lower recidivism rates. Access to housing, employment, and education will reduce recidivism and increase public safety. Missouri Appleseed respectfully requests the Missouri House General Laws Committee vote due pass on both HB 2108 and HB 2555.

 Re: Testimony in Support of HB 2108, HB 2555, "Clean Slate" Chair Riley, Vice Chair Hicks, Ranking Member Ingle, and Members of the Committee, My name is Grover Norquist, I am President of Americans for Tax Reform. Thank you for the opportunity to testify in support of House Bill 2108 and House Bill 2555, "Clean Slate" legislation. When someone commits a crime, priority one for government should be apprehending them and ensuring they are brought to justice and pay for that crime. Once they have fulfilled their sentence, there should not be endless consequences for those that do not offend again. Unfortunately, with a confusing, costly, and complicated system for expungement and record sealing, even those former offenders who prove they can stay on the straight-and-narrow over a long period of years will pay through collateral consequences far beyond those they have been duly sentenced to. For conservatives working on criminal justice issues, public safety must come first. Under Clean Slate anyone who reoffends is not eligible for automated expungement. The government would keep records that would no longer be publicly available, which could be used in court proceedings in the rare event someone did reoffend after expungement. A limited number of offenses could be expunged from their records. Justice Department figures show that re-arrest for former nonviolent offenders is rare five or more years after release. A study found the vast majority (82%) of those arrested during a nine year period were arrested during the first three years. This policy, when done responsibly, is a proven success. Pennsylvania and Utah were the first two states to set the model for responsible automated record sealing and expungement. Since passage, over 1.2 million Pennsylvanians have had a record sealed, and it is estimated over 400,000 records will be expunged in Utah. More states have joined them and implemented good Clean Slate policies, like Oklahoma. 10 total states have enacted a version of Clean Slate. Incentivizing a path of working and contributing to the community can improve public safety. A good job helps reduce the risk of recidivism. The economy will also benefit as law-abiding former offenders are able to take on new jobs and grow a career. A study from University of Michigan law school researchers found people's wages went up by 20% on average one year after expunging their record. With 100 job openings per every 53 available workers, Missouri continues to face a significant workforce shortage. Healthcare has been particularly impacted. Clean Slate offers the opportunity to get law-abiding potential workers into new jobs to help address the shortage. Clean Slate offers someone the chance to pursue a hard-earned second chance. Nothing is given away. For these reasons, ATR urges you to support this important legislation. Thank you.

March 22, 2024 To: Chairman Riley and Members, House General Laws Committee Re: HB 2108 and HB 2555 Honorable Chair and Members of the General Laws Committee: We are testifying on behalf of Women's Voices Raised for Social Justice in support of House Bills 2108 and 2555, often referred to as Clean Slate legislation. Women's Voices, founded in 2005, is a nonpartisan organization of more than 400 St. Louis area members with 2000 social media subscribers. Our mission is two-fold: education on a wide variety of issues through free public programs, and advocacy through our members and subscribers engaging in rallies, letter writing, volunteering, and testifying. Our interest in Clean Slate initiatives began three years ago when we hosted a program that focused on reentry services for formerly incarcerated people in the St. Louis area. It was eye-opening to learn of the multiple obstacles because of a criminal record, no matter how minor, that face people returning to our communities. We listened to the life-stories of people who have struggled and even succeeded, but who still carry the heavy baggage of criminal records. Simply put, people continue to pay for the same crime over and over, rather than being able to move on, enhance their lives, and contribute to society. We asked ourselves where is the balance between punishment and ruining lives? And if Missouri's statutes have provisions for expunging certain criminal records, why weren't more people seeking and receiving relief? We subsequently learned that 98-99% of those eligible for expungement are unable to navigate the current petition process, leaving half a million Missourians with criminal records that the law already says can be expunged. This is neither fair to individuals and their families, nor desirable for our communities. Continuing to effectively bar ex-offenders from employment and housing makes zero sense and is a recipe for recidivism. According to the Missouri DOC, 69% of those who are unable to find full-time employment return to prison within two years, making communities less safe and costing taxpayers for reincarceration. We researched national and state Clean Slate initiatives and later joined the Missouri Clean Slate Campaign as a partnering organization. Since 2018 twelve states, recognizing that 25% to 40% of their adult populations were similarly hindered by criminal records, have enacted Clean Slate legislation with wide bipartisan support. Pennsylvania, the first state to adopt automated expungement, has expanded expungement eligibility two times after having already sealed the records of 1.2 million people. In Philadelphia more than 1,000 formerly incarcerated people who had their records expunged through gubernatorial pardons were followed for a decade by two studies, one on recidivism and the other on economic benefits. The studies**, published in 2020, revealed an extremely low (1%) rate of recidivism and impressive economic benefits to individuals and neighborhoods. They concluded that increasing expungements could provide a no-cost economic investment across the state, especially in areas most in need of growth, and that there were no public safety concerns. We are grateful to Representatives Christofanelli and Hicks for introducing House Bills 2108 and 2555. We firmly believe Clean Slate legislation is smart on crime, makes good business

sense, and will boost local and state economies for the following reasons:• Many of the half million eligible individuals will have the opportunity to earn a decent living, obtain stable housing, and provide for their families. • Employers will be able to expand their workforce with qualified people eager and able to work. • Missouri will save taxpayer dollars by bringing more people into the workforce and interrupting the cycle of recidivism and reincarceration. The stigma of a criminal record is a major driver of poverty, which in turn is the strongest predictor for recidivism and the cycle of reincarceration. • Communities will be safer due to lower recidivism rates as more people are able to move on with their lives and provide for their families. • Missouri's courts and prosecutors' offices will no longer be burdened with the costs of record-clearing petitions, saving taxpayer dollars. A criminal record should not be a life sentence to poverty. We firmly believe it is in our community's best interest to have healthy, self-sufficient individuals and families who, with obstacles removed, are more likely to engage in their neighborhoods, seek more education, volunteer at their children's schools, and pay taxes. We add our voices to those who believe a Clean Slate Act will provide both help and hope to the half-million Missourians who are currently eligible for record expungement. It is also the right and fair thing to do. We thank you for your time and request your support on House Bills 2108 and 2555. Dear Chairman Riley and Members of the Senate Committee on General Laws: On behalf of the Springfield Area Chamber of Commerce and our 1500-member businesses, please accept this letter of support for House Bill 2108, sponsored by Rep. Christofanelli, and House Bill 2555, sponsored by Rep. Hicks. These bills would establish a process for automatic expungement of certain criminal histories, ensuring a common-sense solution to give the business community access to a strong talent pipeline, supporting the state's economic future. Approximately 1.9 million Missourians have some form of a criminal record. This can present unnecessary barriers to employment, housing, education, occupational licensing, and other services. These obstacles persist long after someone has served their time, contributing to Long-standing workforce barriers. While tens of thousands of Missourians are currently eligible to have their records cleared, the existing petition-based system is costly, complex, and time-consuming; less than one percent will actually complete the process. In practice, that means that thousands of our neighbors are being denied the relief – and the economic opportunities – they deserve. For individuals with records, the impact of automatic record clearance could increase wages by more than 20 percent within one year alone and increase an individual's likelihood of finding employment to begin with. That becomes critical at a moment when businesses across our great state are struggling. With unemployment rates already at historic lows, and only 53 available workers for every 100 open jobs, we need to expand the talent pool for our employers. Experts also estimate that the U.S. economy loses as much as \$87 billion in GDP per year due to the underemployment of formerly incarcerated people. Clean Slate would ease the burden for companies that are desperately trying to hire by allowing them to recruit from a new and underutilized pool of talent. In turn, this will strengthen both the economy and the labor market. Thank you for your consideration of these impactful proposals and we encourage your support of House Bills 2108 and 2555. I urge you to support HB2108 (Christofanelli) and HB2555 (Hicks), which offer Clean Slates to our neighbors with criminal records who are eligible for expungement but are unable to access it. Automating the record clearing process is good for our community and our neighbors. Our communities thrive when people have access to basic human needs, and a past record should not prevent our neighbors from accessing housing, better paying jobs, recreation, and volunteer opportunities. Criminal records should not be a life sentence. Current Missouri law recognizes that by allowing the expungement process for up to three misdemeanors and a felony. However, we understand that the current petition based process is cumbersome and expensive, meaning only the richest and most connected of our neighbors are able to access expungement. Fewer than 1% of eligible people are able to access expungement, despite its life changing potential. Missouri is a state which values hard work and growth. Records keep folks trapped in their past bad choices, instead of celebrating change. Automating record clearing levels the playing field, allowing people to move on from mistakes. People with cleared records are less likely to commit another crime, helping to keep our neighborhoods safer. With over 1.9 million adults with records in Missouri, the time is now to clear as many records as possible. Our communities struggle to fill jobs. A person with a past criminal record may be the perfect candidate, but unable to access this job because of a past charge. Within one year of record clearing, people are 11% more likely to be employed and earn an average of 22% higher wages. Our friends, family members, and neighbors deserve a true second chance through automated record clearance. We urge the Missouri state Legislature to pass legislation to implement record clearance in Missouri as soon as possible. We have waited long enough.

I am writing to ask that you support Clean Slate legislation that is now before this committee. Most of us can think of a time when we did something that we don't feel proud of, and we know how important it is to be given a second chance in life. For example, my brother-in-law tells a story of how some high school classmates accidentally set a marsh on fire. Though the authorities found out, law enforcement saw fit to give them grace rather than to prosecute. How different their lives may have been had they not had this second chance! With this second chance in mind, the Missouri legislature previously passed laws allowing individuals to petition to seal the records of certain misdemeanors and non-violent felonies some time after they serve their sentence and pay any related penalties. Many employers, landlords, and colleges use criminal background checks to screen applicants. Ideally, the records of these convictions – and of arrests -- would no longer be public, and, in turn, they would not be used to deny Missourians that second chance, keeping them from getting a job, a place to live, or further schooling. But over the years only a very few of those intended to benefit from the petition process – about 1% -- have been able to access those benefits. The process is complicated and confusing, and many of the intended beneficiaries lack the funds for court costs or an attorney. But there is a remedy. Through Clean Slate bills currently before this committee, the promise to remove public records of these convictions and arrests will finally be fulfilled automatically. And once those records are sealed, those with convictions and arrests, as well as their families, will benefit. And the legislation will benefit the State as a whole when Missourians are given the opportunity to fulfill their potential and contribute to the community. Recognizing how the community benefits from Clean Slate legislation, a range of organizations, including the Missouri Chamber of Commerce, have expressed their support. I strongly urge you to support Clean Slate legislation and vote it out of committee with a "Do Pass" designation. Thank you so much for your time and consideration of this legislation that provides Missourians with a second chance, rather than a lifetime of punishment long after they have served their sentence. The Jewish Community Relations Council (JCRC), guided by Jewish values, advocates, educates, collaborates, and mobilizes action on issues important to the Jewish community, 60,000 strong in St. Louis. We are committed to pursuing religious tolerance, civic discourse, and social justice in St. Louis and beyond. Jews have a deeply held belief in teshuva, loosely translated as change/turning our actions and the course of our lives. In other words, we believe in the possibility of rehabilitation and redemption for all people if they seize the opportunities and are willing to learn and grow. As stated in Ezekiel (33:11), "I have no pleasure in the death of the wicked, but that the wicked turn from his way and live." The JCRC reaffirms the Biblical precept that people who offend are human beings, capable of reshaping their lives and worthy of an opportunity to repent and reenter society. HB 2108, referred to as Clean Slate legislation, is a necessary step for allowing justice involved people to reshape their lives and enter society. Throughout our history, the Jewish people know what is liked to be labeled and how that label leads to discrimination. Throughout Europe in the 1930's and 40's people who identified as Jewish were forced to wear a yellow Jewish star on their clothing; and many other marginalized groups were forced to identify themselves with a visible symbol. These symbols enabled the rest of society to openly discriminate against citizens in many ways - in education, in employment opportunities, in jobs, and in access to daily activities like purchasing food, checking out library books, entering public spaces. A person's criminal record is their label. While not immediately visible, like symbols sewn on clothing, it jumps out to grab the attention of employers, landlords, colleges and universities - anyone who uses background checks to make decisions and enables discrimination. With the dependence of technology in all fields, justice- involved people now have a digital symbol that they are unworthy of opportunities. Our criminal justice system was not designed to punish people for the rest of their lives; but that is what is occurring.? Nearly 9 in 10 employers use background checks in their hiring process ? An estimated 4 in 5 landlords use background checks on prospective tenants? More than 3 in 5 colleges and universities use background checks in admissions. Between 60 percent and 75 percent of formerly incarcerated individuals remain unemployed one year after their release. As a result, previously incarcerated people are 10 times more likely than the general public to end up homeless. The Legislature has passed several bills that would improve the chances for those who are justice-involved. These include Fresh Start legislation and the ability to expunge criminal records for many offenses. The challenge is that the expungement process is onerous. It's timely, it's costly, and can involve travel. It is out of reach of many people who are eligible for it. As a result, less than one percent of Missourians who are eligible to have their records expunged are actually able to achieve those expungements. This bill would automate the process so that everyone who has earned the opportunity for a Clean Slate is provided that second chance. The majority of our justice-involved citizens have served their time and are working to turn their lives around. They have

paid their debt to society, but their records create a digital label that enables constant discrimination. They have earned a second chance, and we have the opportunity and the obligation to extend it to them– for the common good. For these reasons we support and urge the passage of HB 2108, Clean Slate expungement legislation.

My name is Bryan Feemster. I am the Circuit Clerk of Greene County, Missouri. I am providing information I hope will be helpful in vetting HB 2108. HB 2108 applies to electronic/digital records. Greene County has records stored on the state electronic system back to 2008. We previously used a local electronic record system (WRITS) between 1990 and 2008. The WRITS system stored summary information while most documents were paper. Everything previous to 1990 was stored as paper files. The requirement to search electronic records appears to include those stored on our defunct WRITS system. Our experience expunging marijuana charges in compliance with a recent amendment to the Missouri Constitution gives valuable insight into what to expect from HB 2108. The Greene County marijuana expungement process follows the following steps: 1. The Office of State Courts Administrator (OSCA) searched digital court records for cases with potential eligible charges and provided lists to Circuit Clerks. 2. The Circuit Clerk's Office processed these lists of thousands of cases. One cannot rely on a computer search to positively identify eligible charges. Documentation of each case was individually reviewed by an experienced Clerk to determine whether documentation contained an eligible charge(s). Note: It appears HB 2108 would require all of this to be completed before the monthly list of clean slate eligible offenses is sent to the central repository and prosecuting agencies. 3. Proposed Orders of Expungement were prepared by Clerks and sent to court for review. 4. Clerks performed expungements for cases approved by the court. Note: HB 2108 directs that expungements be completed within 30 days of being sent to the courts by OSCA. This is not enough time to expunge our court records. Greene County Clerks spend more than two hours per marijuana expungement case. Greene County has expunged more than 4,200 cases. We are not yet done with digital records. We have been working on this project since February, 2023. HB 2108 would result in many more expunged cases and required resources than the marijuana project. There is no such thing as automated expungement. HB 2108 expungements compare to marijuana expungements in the following ways: 1. Each marijuana case can be processed without checking any other case. HB 2108 limits total lifetime charges that may be expunged requiring a state-wide tracking system. The entire electronic criminal history for every individual must be searched to determine whether they have exceeded the lifetime limit. This will have to be verified by searching every document in every case for each individual (probably using a social security number since variations on names are commonly used). 2. HB 2108 would require searching for numerous types of offenses. 3. People who move frequently or have moved recently could have undetected ineligible offenses in other states. 4. There are four exceptions that prevent a marijuana charge from being eligible for expungement. There are 91 statute references listed in RSMo 610.140 as exceptions to expungement plus other exceptions such as not having paid restitution. Since non-digital records are not searched, exceptions stored on paper or microfiche will not be known. 5. Very few people have contacted us about marijuana expungements. Interest seems to be low. This may be indicative of a low level of

interest in HB 2108 expungements.6. We are unable to notify a majority of people their marijuana expungement has been completed (the majority of mail notifications are returned). This may also be the case with HB 2108 since we would not have information normally contained in a petition. Circuit Clerks are passionate about our responsibility to serve people utilizing the Missouri court system. Intended beneficiaries of HB 2108 will have no stake, little understanding, and likely no knowledge of their expungement. Here are a couple of suggestions that might improve results:1. Treatment courts require an application from potential participants to verify genuine interest in improving their future. Circuit Clerk's would suggest a requirement to complete a petition for expungement would verify an interest in people seeking to improve their lives. The information provided in the petition would reduce tax payer money spent searching for this information and provide current contact information used by the Circuit Clerk to notify the petitioner about results.2. An education program designed to let people know they are eligible under the current 610.140 program, how to file a petition, and what the benefits of expungement are could be a worthy project.
