This bill clarifies the exemption of machinery and equipment used to provide broadband services from sales/use taxes. The Missouri Supreme Court in April 2023 ruled such items were exempt when used to provide telecommunications services. All, or nearly all, of the equipment used to provide broadband also provides telecommunications services (VOIP) to at least one customer. Therefore, this bill simply clarifies the issue for the Mo. Dept. of Revenue and prevents confusion and unnecessary future legal battles.
