I represent Kansas City Pet Project, a 501c3, nonprofit charitable organization operating the Kansas City, Missouri Animal Shelter. We are the contracted agency enforcing the city code of ordinances for animals and caring for all impounded animals in Kansas City. KC Pet Project is opposed to HB 2265, which would prohibit local governments from adopting or enforcing ordinances that prohibit or effectively prohibit the operation of a pet shop. KC Pet Project is the largest animal shelter in the state, and we work tirelessly to increase the number of homeless pets adopted, enhance public safety, and focus on lifesaving programs promoting pet retention. We have seen animal intakes rise dramatically by 28% in the last two years. For dogs alone, we took in 1,853 more dogs in 2022 than we did in 2021. Our shelter took in 15,631 animals in 2023, many of these animals from owners who could no longer care for their pet due to financial reasons. In fact, financial hardship is consistently in the top 3 reasons why families can no longer keep their pets. HB 2265 would most certainly result in the continued growth of pet stores selling overpriced animals in Missouri to unsuspecting owners falling prey to the pet stores' predatory business practices. With an ever-increasing number of animals ending up in Missouri animal shelters that are already operating in a state of constant overwhelm, taking away a local government's ability to control the animal shelter intake and taxpayer burden that pet stores inherently put on their community is an overreach by the legislature.
