Associated Industries of Missouri supports the bill that lowers the corporation income tax rate, making Missouri more competitive with other states and nations. HOWEVER, we strongly urge the sponsor to remove subsection 6, subdivision (2) that would prohibit banks and other financial institutions from enjoying this tax cut. The provisions of section 148.720, RSMo, were passed into law in 2018 to address this very situation and to be sure financial institutions, that do not pay corporation income tax, could enjoy the benefit of corporation income tax reductions because of the way the financial institutions tax is calculated. If this provision is not removed, we would be forced to oppose the bill because it would not provide equal benefit to all corporations.
