The Sierra Club Missouri Chapter opposes House Bill 2282. We have building codes and require permits for a reason. The public and homeowners need to be protected by these codes. The maximum fine amount of \$5,000 in this bill is too small and the 1-year time limit is too short. This could easily be abused by negligent and unqualified home flippers. Also, the language that the permit be waived if the political subdivision doesn't respond within 20 days is also dangerous. Required inspections and permits should never be waived.
