9-1-1 governing bodies that have a 9-1-1 sales tax and now have a county-use tax collection system are experiencing declining sales tax revenue. This is because the 9-1-1 districts do not receive any of the use tax dollars collected from the county. The problem becomes more significant as more people opt to buy online. Therefore, there is a need to explore potential solutions to this issue and recapture the loss to ensure that 9-1-1 centers can continue to operate effectively. This bill allows options to be pursued.
