I work for MOST Policy Initiative. We are a local non-profit that provides non-partisan research services for the Missouri state legislature. I will be speaking on the information found in our Science Note non-consensual sexual explicit media. Revenge porn is distributing sexually explicit media without a person's consent. Subjects of revenge porn are more likely to experience negative effects such as PTSD, anxiety, depression, suicidal thoughts, and damage to social relationships. Among people who use online dating platforms, people part of the LGBTQ+ community are more likely to be threatened or victimized by revenge porn than the general population. As of May 2022, 46 states and Washington D.C. have passed laws regarding the production or distribution of nonconsensual pornographic content. However, it is not a federal crime.
