Paraquad is one of Missouri's 22 centers for independent living, advocating for equity and independence for people with disabilities through services, partnerships, education, and advocacy. We provide five core services: peer counseling, advocacy, independent living skills training, information and referral, and transitions (from nursing home to community, from youth to post-secondary life, etc.). People with disabilities are more likely to live in poverty and also frequently have transportation challenges. This may shape the choices we make when having cancer screenings. We appreciate Rep. Nickson-Clark's effort here to make sure that those who otherwise meet eligibility requirements for MO HealthNet medical assistance for treatment of breast or cervical cancer are eligible for medical assistance regardless of whether the screening service was provided by a provider who receives or uses funds under that title. Medicaid saves many lives. It is important to encourage those on Medicaid to regularly be checked for breast cancer and other cancers.
