This amendment would eliminate voting as a right of citizenship in Missouri. This is not overheated rhetoric. It is the plain language of the amendment. It would enable the General Assembly to deny suffrage to the unemployed, the unhoused, the uneducated, or anyone not approved by a partisan Secretary of State. If you really just want to make sure that non-citizens and non-residents can't vote, the sentence at the end of Section A does the trick. Changing "All" to "Only" at the beginning of Section A invites all manner of mischief. I would like to think that is not the intent, but it will be the effect.
