Madam Chair and members of the committee, my name is Amy Kuo Hammerman, and I am submitting this testimony in opposition of HJR 67 on behalf of the National Council of Jewish Women St. Louis (NCJWSTL). NCJWSTL is a non-profit organization in metropolitan St. Louis, representing over 5,000 members and supporters throughout the state. We focus our work on community service, advocacy, education and philanthropy to improve the quality of life for women, children and families while supporting individual and civil rights, and have been doing so since 1895. HJR 67 would require proponents of proposed constitutional amendments to obtain signatures from 8% of the registered voters in all of Missouri’s congressional districts, rather than in six of eight of the districts as is currently required. For more than a century, Missouri citizens across the political spectrum have been able to have their voices heard through the initiative petition process. I have a difficult time understanding why legislators wish to fix something that is not broken. Requiring more signatures than has been sufficient for the process for over a hundreds years is unnecessary. Moreover, this measure implies that the signatures in some congressional districts don’t count as much as others. Adding this barrier does nothing more than censure the voice of the people. Lawmakers should reject efforts to make direct democracy more difficult. NCJWSTL encourages you to vote no on HJR 67.

I am a Co-Director of the Inter-Faith Committee on Latin America (IFCLA), an organization that has worked alongside immigrants and their families for more than 40 years, supporting their work for full inclusion in Missouri life. On behalf of IFCLA and the individuals and congregations we represent, I urge this committee to uphold our most direct form of democracy and reject HJR 67. The initiative petition process has been a beacon of representative government. It is an important tool of direct democracy that allows Missourians to make our voices heard on important issues in the state that we love. HJR 67 is attempting to change the initiative petition process to restrict our freedom. It would end majority rule in Missouri and take away our right to decide what happens in our own state. Our Missouri Constitution has long guaranteed that “the people reserve power to propose and enact or reject laws and amendments to the constitution by the initiative, independent of the general assembly.” HJR 67 is a clear attack on the century old tradition of majority rule in Missouri. Allowing the minority to veto decisions about laws in our state makes no sense and violates the sacred principle of one person, one vote. If a majority of Missourians support a law, it should be the law. Keeping a simple majority as it’s been for more than 100 years is just common sense. Voters from all sides of the political spectrum have used the initiative petition process to advance their priorities. This process is the only recourse voters have when politicians fail to address the issues that matter to us. If this legislation is to pass, future generations will not have the same rights that we do. We should not seek to permanently alter our constitution and deprive future citizens of the rights we all currently enjoy. Good Day, A fully-paid Golden Life member of both THE NAACP and THE Delta Sigma Theta Sorority, Inc., a public service sisterhood founded on Christian principles, I have visited the Missouri Capitol several times over the years. I traveled from Kansas City as part of our Social Action Committee's annual Delta Days at the Missouri State Capital. I was an advocate of Medicaid Expansion. Established in 1913 at Howard University in Washington, DC, Delta's first social action was marching down Pennsylvania Avenue for women's suffrage. Communities Creating Opportunities and other community and faith-based organizations sponsored several bus trips to the Missouri State Capital in Jefferson City in support of Medicaid Expansion for citizens caught in the Affordable Health Care gap. I was impressed with the historic art and accessibility to the legislative process. The hallowed halls featured pictures of respected public servants such as Senator Yvonne Wilson and Representatives Mary Groves Bland, Bill Gray and Jackie McGee. Most legislators live up to the title, The Honorable. Years before, I wrote to The Honorable John Ashcroft, Missouri's 50th Governor (1984-1993) who went on to serve as US Senator (1995-2001) and 79th US Attorney General, aka Justice Dept CEO (2001-2005). I urged him to sign the bill on his desk passed by a progressive Missouri House and Senate to divest Missouri funds in an international response to apartheid in South Africa and then enforce the law he signed when the MOSERS (MO State Employees Retirement System) Board refused to comply 5 years later. I was surprised, both times. He did the honorable thing after I appealed to him citing Old Testament references in the name of Jesus. I supposed as a Republican, he would not sign the Democratic led divestment bill into law. Little did I know, he was the son of a Pentecostal preacher and was not Jewish as I assumed. I try to leave judging people to the Lord God Almighty now. Nobel Peace Prize Winner, Archbishop Desmond Tutu visited UMKC and praised Missouri's forward thinking in this important fight for human rights. Divestment did not cost the state any money as was predicted. In fact, funds increased. Nelson Mandela, another Nobel Peace Prize Winner, was subsequently released from prison after 27 years. He went on to vote for the first time in a presidential election he won. GLORY TO GOD. I do not understand why Medicaid Expansion did not pass the Missouri legislature. How could a state legislature refuse billion\$ of federal funding to comply with the spirit of federal law in deference to public health? Your health care is partially funded by the taxpayers in the gap!!! Many benefited from Affordable Health Care (aka, Obama Care) especially during the COVID-19 pandemic. Missouri has profited from the influx of federal funding as one of the 41 Medicaid Expansion states. This was accomplished via a citizens' petition initiative. THE PETITION INITIATIVE PROCESS MUST BE MAINTAINED AS IS. It is an important check to the partisan politics I saw evident in Medicaid Expansion which required Supreme Court intervention to be enacted. The failure of a partisan Missouri legislature to act in the best interests of our citizenry was countered by this process to get the issue on the ballot and passed with the current percentage of signatures in the current number of Congressional Districts with the current simple majority. We were at over 150,000 of the 200,000 mark needed to get this on the ballot this year. We must take care of the working poor as Jesus admonished us to in Matthew 25:40.In 2018, MoJwJ initiated a petition to raise the minimum wage which was then \$7.35. The campaign was successful and the subsequent ballot measure passed. The minimum wage was increased by \$.85/year until 2023 when it capped at \$12/hour.This 2024 measure would increase the minimum wage from \$12/hour to \$13.75 in 2025 and \$15/hour in 2026. A cost-of-living increase provision is attached. This will avoid the necessity of having to come to voters every 5 years.Additionally, paid sick leave based on number of hours worked would be included for other than small businesses. The public mental and physical health benefit of this is people would not have to go to work sick and/or send their children to school sick and make others sick because they have to go to work. This is especially important post-pandemic.Gathering signatures was sometimes very difficult.

1. People were skeptical about giving out personal information. Even when you have on a MoJwJ t-shirt and pass out literature, they can be hesitant. They might favor this bipartisan initiative but will not sign a petition handed to them by a stranger which requires them to provide their address.

- This is a legitimate concern these days given the incidence of identity theft. • Being added to marketing lists causes the nuisance of unwanted solicitations. • They often asked if they can "sign on-line" so they can maintain their privacy.

2. Some Congressional Districts were harder than others. • In Jackson County, we were expected to gather 12 signatures/hour (CD5). • In Congressional District 6, the expectation was 8. Then it was lowered to 5.3. Some businesses have a strict "no solicitation policy". I have been politely and not so politely asked to leave the premises. Even when management agrees in principle with what we were doing, they took the zero-tolerance stance. The threat of being charged with trespassing was evident.

Dear Honorable Committee Members: The ACLU of Missouri (ACLU-MO) submits this testimony in opposition to HJR 67, which would increase the threshold for signature collection prior to placing a constitutional amendment before the voters via citizen initiative petition. The ACLU-MO is the state affiliate of the national ACLU and works in the courts, legislature, and Missouri communities to defend and preserve the civil rights of individual Missourians, specifically of that to vote. The citizen initiative petition process is an essential form of direct democracy in Missouri. For over a century, Missourians from across the political spectrum have employed the process to advance key causes important to the general electorate. If allowed to go forward, HJR 43 would degrade this essential constitutional right. Specifically, HJR 43 proposes increasing the number of signatures required for a petition to appear on the ballot. Currently for initiative measures – depending if they are statutory or constitutional – require signatures from a percentage of voters in two-thirds of Missouri’s congressional districts. HJR 67 raises this threshold by requiring signatures from all of Missouri’s congressional districts. This would greatly increase the number of signatures required and severely degrade access to the process. Currently, a constitutional initiative petition requires approximately 170,000 signatures to appear on the ballot. If adopted, HJR 67 would raise that requirement to over 240,000 signatures, an increase of over 40%. (see Missouri Secretary of State’s Office, Make Your Voice Heard: Missouri’s Initiative Petition Process, 5-6, <https://www.sos.mo.gov/CMSImages/Elections/Petitions/MakeYourVoiceHeard.pdf>) Signature collection efforts are already prohibitively expensive and can cost millions of dollars to obtain the requisite signatures. A 40% increase would mean hundreds of thousands if not millions of more dollars, further limiting who can access this essential right reserved by the people. Requiring more signatures be gathered for ballot qualification adds another hurdle to the people’s power of direct democracy and would potentially prevent important and popular measures from ever reaching the ballot box. I urge you to preserve Missouri's initiative petition process. When legislators pay more attention to special interests than to their constituents, we look to the initiative petition, the most direct form of voter participation in our democracy. Missouri's initiative petition system has been in place for over 115 years. It allows citizens to add their signature to a petition and put an issue on the ballot for a statewide vote. This critical tool, used through the years by citizens from all political persuasions, is now under attack by lawmakers who want to curtail the people's power. This valuable and trusted process is not easy, and the citizens of Missouri have not abused it. The Missouri Legislature is currently proposing at least 24 different bills that would make it more difficult to get an issue on the ballot and/or increase the number of votes needed to pass once on the ballot. These bills (and the legislator who proposed them) are: HB1749 (Haffner), HJR102(Lewis), HJR67 (Billington), HJR72 (Lewis), HJR76 (Hudson), HJR81 (Kelley), HJR86 (Black), HJR91 (Schnelting), HJR93 (Falkner), HJR94 (Richey), HJR99 (Schwadron), SB1003 (Koenig), SB1076 (Koenig), SB1270 (Schroer), SJR48 (Hoskins), SJR49 (Koenig), SJR51 (Eigel), SJR56 (Cierpiot), SJR59 (Brattin), SJR61 (Moon), SJR73 (Schroer), SJR74 (Coleman), SJR77 (Carter), SJR79 (Brown), SJR81 (Carter), and SJR83 (Eigel) thus far. Missouri's current requirement for passage of an initiative petition is a simple majority of votes cast. Proposed changes would raise that requirement to 60% or even 67%. Others require a majority of votes cast in a majority of Missouri's representative districts. It is absurd and unprecedented to require more than a simple majority of votes cast to approve an issue in Missouri. It is already difficult to meet the current requirement of gathering enough signatures from 8% of voters in six of Missouri's eight Congressional districts to qualify for the statewide ballot. Several proposed bills would increase that to 10% in all districts, requiring hundreds of thousands more signatures and making it almost impossible to get an issue on the ballot. This is unacceptable. Our officials are elected by simple majority vote and can legislate by simple majority vote. It's hypocritical for them to legislate that we, their constituents, must then require 60-67% of the vote to pass ballot measures to counter their unpopular legislation. How is it that today's majority vote can restrict the Missouri voters of tomorrow and reverse over 115 years of precedent? Our democracy depends on the power of people to be directly involved in their government. The initiative petition process is a sacred and trusted right of the citizens of Missouri. I urge you to oppose any bill that restricts the initiative petition process in any way.

My name is Mads Friske and I have been a volunteer signature gatherer for multiple ballot initiative campaigns. Regardless of the outcome of the campaign, I have valued the chance the initiative process has given me to discuss issues that my neighbors in Springfield, Missouri, face. I have had conversations with folks I never would have imagined to agree with via some of the initiatives I've backed, and the process has made my community feel more like a community. I've had hundreds of conversations with registered voters in Missouri - some of whom agreed with me and signed the petition, others who wanted time to think about it, and others who disagreed and didn't want to sign. But, all of the conversations were valuable to me and to the voter, because we were able to feel engaged about the issues facing our state. I vote regularly in elections, and I understand that sometimes my candidate or issue will win, and sometimes they will lose - but that is what democracy is. It is when everyone gets an equal chance to weigh in. Proposals that seek to do the opposite, are fundamentally undemocratic and unAmerican. This legislation will only further polarize our community and frustrate our citizenry because it means that the majority is being silenced by a minority. A majority is 50% plus 1. Changing the threshold just makes it harder for the public to make decisions. The process is already rigorous - you have to get hundreds of thousands of voters to sign on, with their correct registered voting address, from all parts of the state, before a measure even gets considered for the ballot. Adding additional barriers does nothing more than censor the voice of the people. Voters from all sides of the political spectrum have used the ballot initiative process to advance their priorities. The ballot initiative process is the only recourse voters have when politicians fail to address the issues that matter to them. This tool has been used by conservatives, progressives, moderates, and independents. I was granted the right to petition my neighbors directly as a voter in Missouri, if I ever felt that our government wasn't prioritizing things properly. I was inherited this privilege by previous generations of Missourians. It is a tool in our democratic toolbox. Future generations won't have the same rights as mine if this legislation is passed. Since 1907, Missouri's constitution has guaranteed, "The people reserve power to propose and enact or reject laws and amendments to the constitution by the initiative, independent of the general assembly." It is not appropriate for us to deny future generations the rights that we presently have. I am opposed to this legislation because it would fundamentally alter the direct democracy that we've had access to in Missouri for over a hundred years, a process that gives Missourians a chance to work together for a change. I respectfully request that you vote no.

Chair, Vice-Chair, members of the committee; thank you for the opportunity to submit testimony today in opposition to HJRS 67 & 93 which would squander the opportunity for the working people and families of the Show me state to effectively participate in their own democracy. Abortion Action Missouri, formerly Pro Choice Missouri, works to protect and expand every Missourians’ right to bodily autonomy, to access essential reproductive healthcare including abortion care, to access accurate information to make the best decisions for ourselves and our families, and to parent our children in safety and dignity.HJRS 67 & 93 would make the ballot initiative process prohibitively difficult, because the task is already a monumental one. House Joint Resolution No. 67 seeks to weaken this power by proposing a constitutional amendment that would make it harder for Missourians to participate in the democratic process. For this reason, we respectfully ask that you oppose HJR 67. The constitutional amendment outlined in HJR 67 specifically requires initiative petitions to be signed by 8% of voters in each congressional district in Missouri if the petition is proposing a constitutional amendment and 5% of voters in two thirds of Missouri's congressional districts if the petition is proposing a law. This modifies the current requirement that petitions be signed by the aforementioned percentage of voters in two-thirds of the congressional districts. The official fiscal analysis of HJR 67 projects that this will increase the number of required signatures by 40%, which would make it significantly more difficult for Missourians to make their voices heard. The Constitutional sections at issue in this bill, as currently written, were designed to give Missourians the right to independently engage in the legislative process in the face of corrupt politicians. Any attempt by politicians to weaken this right is only further proof of this process's importance. Once again, the Missouri Coalition for the Environment asks you to vote "no" on HJR 67 in order to preserve the constitutional right of Missourians to engage in the initiative petition process without interference from politicians who wish to make this process more difficult. I urge you to preserve Missouri's initiative petition process. When legislators pay more attention to special interests than to their constituents, we look to the initiative petition, the most direct form of voter participation in our democracy. Missouri's initiative petition system has been in place for over 115 years. It allows citizens to add their signature to a petition and put an issue on the ballot for a statewide vote. This critical tool, used through the years by citizens from all political persuasions, is now under attack by lawmakers who want to curtail the people's power. This valuable and trusted process is not easy, and the citizens of Missouri have not abused it. The Missouri Legislature is currently proposing at least 24 different bills that would make it more difficult to get an issue on the ballot and/or increase the number of votes needed to pass once on the ballot. These bills (and the legislator who proposed them) are: HB1749 (Haffner), HJR102(Lewis), HJR67 (Billington), HJR72 (Lewis), HJR76 (Hudson), HJR81 (Kelley), HJR86 (Black), HJR91 (Schnelting), HJR93 (Falkner), HJR94 (Richey), HJR99 (Schwadron), SB1003 (Koenig), SB1076 (Koenig), SB1270 (Schroer), SJR48 (Hoskins), SJR49 (Koenig), SJR51 (Eigel), SJR56 (Cierpiot), SJR59 (Brattin), SJR61 (Moon), SJR73 (Schroer), SJR74 (Coleman), SJR77 (Carter), SJR79 (Brown), SJR81 (Carter), and SJR83 (Eigel) thus far. Missouri's current requirement for passage of an initiative petition is a simple majority of votes cast. Proposed changes would raise that requirement to 60% or even 67%. Others require a majority of votes cast in a majority of Missouri's representative districts. It is absurd and unprecedented to require more than a simple majority of votes cast to approve an issue in Missouri. It is already difficult to meet the current requirement of gathering enough signatures from 8% of voters in six of Missouri's eight Congressional districts to qualify for the statewide ballot. Several proposed bills would increase that to 10% in all districts, requiring hundreds of thousands more signatures and making it almost impossible to get an issue on the ballot. This is unacceptable. Our officials are elected by simple majority vote and can legislate by simple majority vote. It's hypocritical for them to legislate that we, their constituents, must then require 60-67% of the vote to pass ballot measures to counter their unpopular legislation. How is it that today's majority vote can restrict the Missouri voters of tomorrow and reverse over 115 years of precedent? Our democracy depends on the power of people to be directly involved in their government. The initiative petition process is a sacred and trusted right of the citizens of Missouri. I urge you to oppose any bill that restricts the initiative petition process in any way.

I am the Rev. Dr. Teresa Danieley, a lifelong Missourian. I have participated in grassroots initiative petition campaigns many times as both a volunteer from 2005 to 2012 and as a staff person at Missouri Jobs with Justice since 2017. I first participated in gathering signatures to raise the minimum wage in 2005-2006 because, as a parish priest in the City of St. Louis, I encountered many parishioners and members of the wider community who were working for minimum wage, but struggling to make ends meet. Raising the minimum wage seemed like a common sense way to alleviate suffering and the need for working people to seek charity. In November 2006, that first increase in the minimum wage won easily statewide, across geographic and political boundaries. The initiative petition process is non-partisan and used by people across the political and philosophical spectrum. Since that first experience with the Missouri initiative petition process, I have participated again many times, as both a volunteer and a staff person. I have spent all day outside polling places and along parade routes in blazing heat and freezing cold. I have collected signatures in churches, synagogues, mosques, and union halls. Even in the nicest weather with the friendliest crowd, the signature gathering is slow, tedious work, filling pages ten signatures at a time. In the past year, I have also been notarizing initiative petitions and found that it is more complex to notarize an initiative petition than it is to notarize someone's advance health directive. One small mistake on my part could disqualify the signatures of ten Missouri voters and the hard work of a signature gathering volunteer. As a Missourian, I am proud that we have had the grassroots ballot initiative petition process available to us since 1907 as an important tool of direct democracy. The initiative petition process allows us to maintain our freedom to have a say on important issues. Qualifying a grassroots ballot initiative is already incredibly difficult. Making it even more difficult does nothing other than undermine democracy. As a Missouri voter, I have had the right to directly petition my neighbors if I thought our government wasn't prioritizing the right things. This right was passed down to me from previous generations of Missourians. It is part of our toolkit of democracy. If this legislation is to pass, future generations will not have the same rights that I do. We should not seek to permanently alter our constitution and deprive future citizens of the rights we all currently enjoy. A majority is 50% plus 1. Changing the threshold is undemocratic and would make it harder for the public to make decisions. As I have described from my own experience, the initiative petition process is already rigorous and incredibly difficult - hundreds of thousands of voters must sign on before a measure even gets considered for the ballot. Adding additional barriers does nothing more than censure the voice of the people. I respectfully request that you vote no on undermining majority rule. One person, one vote.

As the largest and oldest anti-poverty non-profit in our state, Empower Missouri is committed to improving the quality of life for all Missouri residents through advocacy. On behalf of our staff, board, and coalition members, we express our opposition to HJR 67 and HJR 93. We respectfully ask this committee not to advance any legislation which will alter Missouri's existing initiative petition process, including the two bills before it today. The initiative petition process is foundational to the Missouri law making process and ensures each Missourian has a voice in the laws that govern our state. The modifications proposed in HJR 67 and HJR 93 only serve to make it more difficult for Missourians to raise constitutional amendments for a vote of their fellow citizens at the ballot box. HJR 67 unnecessarily increases the number of Congressional districts in which initiative petition signatures must be collected, from the current requirement of two-thirds of Congressional districts to a full 100 percent of Congressional districts. This modification would drastically increase the time and resources required to complete what is already a resource-intensive signature gathering process, only serving to make the initiative petition process more inaccessible to Missouri citizens. HJR 93 unnecessarily increases the voter approval threshold from the longstanding simple majority of 50% plus one to 55% when amending the Missouri Constitution or imposes the state legislative body into the people's initiative petition process, requiring both chambers to hold committee hearings and floor debate on every certified initiative petition before it can appear on the ballot. This inflicts another roadblock requiring citizen-led initiative petitions to complete the signature gathering and certification process in advance of a newly imposed, arbitrary deadline. Missourians can and should be trusted to utilize the initiative petition process without unnecessary interference from the state legislature. The initiative petition process is one of the most important avenues for Missourians to directly engage in shaping the laws that govern our state. The bills being considered here today propose changes that will effectively exclude regular citizens from accessing the initiative petition process. Please do not take this important democratic tool away from Missourians. We respectfully request your no vote on HJR 67 and HJR 93.

HJR 67 is designed to discourage Missouri citizens from pursuing their constitutional right to use the initiative petition process to place a constitutional amendment on the ballot. Note that the bill does not extend the deadline for submitting signatures for certification, thus adding pressure on signature collectors. It stymies the efforts of average Missouri citizens of all political persuasions who historically have relied on the initiative petition process to put issues on the ballot. There is a spiritual dimension to democracy that has been obscured by the tsunami of anger, fear, animosity, and hatred that has become the norm within politics-as-usual in America today. We need a political revival in America. We also need a spiritual revival. And the political revival will likely be impossible without the spiritual revival. Democracy is rooted in spirituality. The spiritual roots of democracy can be traced to Richard Hooker, an Anglican priest who introduced people's capacity for reason and the concept of natural rights into the religious debates of his time – the 16th century. John Locke was inspired by Hooker as he wrote his Second Treatise of Government. A deeply spiritual man, Locke placed both individual liberty and political power within a moral framework. He stated, as “self-evident” truths, that “all men by nature are equal”, endowed by God with natural rights to “life, health, liberty, (and) possessions”; and that “the consent of the people” is the only “lawful basis” for government. If those ideas sound familiar, it is because they were immortalized by Thomas Jefferson in the Declaration of Independence, which included the “self-evident” Truth that governments derive their “just powers from the consent of the governed”. The essence of Locke’s Second Treatise can be summed up in a single sentence: “The majority, having the whole power of the community naturally in them, may employ all that power in making laws for the community, and executing those laws by officers of their own appointing; and then the form of the government is a perfect democracy.” That same self-evident Truth is reflected in our state’s Constitution, which opens with a powerful proclamation of “the principles on which our government is founded”: “All political power is vested in and derived from the people. All government of right originates from the people, is founded upon their will only, and is instituted solely for the good of the whole.” A government that truly and fully lived up to those ideals would be a perfect democracy. The world has yet to see a perfect democracy. Our governments, in Missouri and in America, may have been founded upon democratic principles but we have never fully lived up to them. Missouri is one of only fifteen states where the citizens can amend the Constitution by majority vote through the initiative process. Instead of looking for ways to roll back democracy in Missouri, I encourage the members of this committee to seek ways to make Missouri a perfect democracy.
