Although there are several positive aspects of SB727, the elements of expanding charter schools to Boone County and increasing access to empowerment scholarships are incredibly flawed. Empowerment scholarships were never intended to increase choice for children with disabilities and students with fewer resources; they are intended to provide tax rebates to influential constituents of Senator Koening, Representative Christofanelli and others. My husband, Terry Henage and I are both retired teachers living in Audrain County. We spent our careers here raising two children who graduated from Mexico Public Schools. I am the Co-President of our local MRTA unit Audrain County Area Public School Retirees representing all public school employees and feel it is necessary to point out why I oppose most parts of this bill, but support others. First, I support statutory increases in teacher salaries with a funding mechanism to implement and sustain the increases, which results in a more secure retirement system for life. Educators deserve their hard-earned pensions. Likewise, a funding mechanism is missing from the SS#2 SCS SB 727 bill which includes provisions to bolster support for small and rural school districts like those in Audrain County through increased funding for the Small Schools Grant Program. I urge the General Assembly to include a funding mechanism for this program as well. The bill also wisely addresses key areas such as early childhood education programs, Teacher Recruitment and Retention State Scholarship Program, suicide prevention, career ladder, literacy promotion, and equity in funding allocation, among others. Each of these components reflects a commitment to advancing public education in Missouri and ensuring that all students have access to the resources and support they need to succeed. I fully support these proposals as well. What I don't support are Charter Schools, and Vouchers because those will have significant negative implications for our public education system. I urge the General Assembly to remove the provisions related to charter schools and the Empowerment Scholarship Accounts Program expansion. It is imperative that any changes to our education system prioritize equity, accountability, and the best interests of all students and communities. The expansion of charter schools to Boone County is something that should be taken to a vote of the citizens who live in the county - local control ensures that the voices of the people are heard at the closest possible level of government.SS#2 SCS SB 727 adds all school districts located in Boone County to the list of school districts in which a charter school may be operated by any entity currently authorized to operate a charter school. Boone County would be exempt from provisions of current law that provide additional state aid to charter schools. Expansion of charter schools reduces the financial support from the state for all public schools in Missouri.SS#2 SCS SB 727 also, expands the maximum amount of tax credits available for the Empowerment Scholarship Accounts Program that may be allocated in any year from \$50 million to \$75 million. That means \$25 million less will be going to our public schools. I oppose charter school and empowerment scholarship expansion as it reduces the resources for all public schools. This diversion of funds can lead to budget constraints, larger class sizes, and reduced resources for many students who remain in traditional public schools. Another major concern by the diversion of resources from traditional public schools to charter schools may lead to a decline in the overall quality of education for many students. In light of these concerns, we urge the General Assembly to remove the provisions related to charter schools and Empowerment Scholarship Accounts Program expansion. It is imperative that any changes to our education system prioritize equity, accountability, and the best interests of all students and communities. The expansion of charter schools to Boone County is something that should be taken to a vote of the citizens that live in the county - local control ensures that the voices of the people are heard at the closest possible level of government.

I. Jacqueline Coop, retired teacher currently working 550 hours in public school districts, am testifying to express my concerns regarding the recent open enrollment bill that has been proposed in Missouri. I feel SB727 has potential detrimental consequences on our public school education system. Public schools are the backbone of many of our communities. Open enrollment could lead to overextending resources for public schools if students are allowed to transfer freely between districts. This puts a hardship on already fixed budgets and/or plan for the number of transferring students into and out of their districts. As a special educator, I am also concerned about meeting the needs of students with disabilities if they are transferring between district and transportation service issues when required by their IEPs. The bill may compound educational inequalities. Schools in affluent, better-off areas may attract a higher number of students, leaving schools in substandard neighborhoods which in turn could backslide our work in keeping schools as equitable as possible and hinder academic success. The bill may inadvertently promote a culture of competition among schools, focusing more on enrollment numbers or in stronger athletic programs than the quality of education provided. I urge our lawmakers to talk to Superintendents and Principals in the areas they serve in order to better understand the long-term ramifications of this open enrollment bill on the education system in Missouri before making community altering decisions. While the intention may be to provide choice and flexibility, we as stewards of ALL MISSOURI STUDENTS must ensure that it does not come at the expense of the quality of education and the well-being of our students. ALL STUDENTS MATTER.

SB727 had started out as a 15-page bill with the purpose of expanding youchers, with some very concerning changes being made to a program that hasn't been fully utilized in the few years it's been in place. When the expansion increased the allowances for youchers to 400% of the FRL levels, it seemed that it was well beyond the original scope of HB349 when implemented. Then, it picked up the expansion of charter schools into Boone County, Saint Louis County and Saint Charles, it turned into a vehicle to put a large hole into public school education with the two-pronged approach. From the initial 15-page bill, the SCS increased it into a 75-page bill and then finally into a more than 150 page bill in size and scope. There are some items that were added to the bill that are pro-public schools. such as increase of minimum teacher pay to \$40,000, incentives to keep a five-day school week, \$5 million for a literacy fund, boosts for the career ladder, as well as other items. Charter school expansion was removed in St Charles County and St Louis County, though retained in Boone County, as a nod to Sen Rowden's home area. The FRL cap was decreased downwards from 400% to 300%, though the voucher program still expands out to \$75, plus the ratcheting mechanism to keep it increasing over time. None of the "ballot candy"-type items have any funding mechanisms in place beyond the scope of the initial items in the bill, so it's unclear how these items could be maintained long-term. Charter school expansion still happens in another area of MO, which is anti-public education, as is the increase in the voucher allowances and total program amounts. These pro-public education items were only added to try and get support from those people that are on the fence or against the bill as originally envisioned, so their true reasons for being added are suspect at best. Even a number of the Senators that voted on the amendments ended up voting against the bill in its perfected form, because at its core, it's anti-public education with the direction of public dollars to vouchers and the expansion of charter schools, which takes public dollars away from public education. All of the added items would have been useful items on their own piece of education legislation, so it's a concern that they were added to an unpalatable bill to get further support than it would have had on its own. Maybe next year, before the budget surplus completely disappears, we re-visit the nonvoucher / non-charter expansion items in this bill and do something truly useful for public education with these added items and put them into existence. As this bill stands, it's still an attack on public education, dressed up in a more favorable appearing package. It can't be supported as-is, which is a shame for that. It would be appreciated if items like increasing base teacher pay, five-day school week incentives, that have a benefit on public education would be put forth on their own without the added issues of needing to get them with increased efforts to privatize local education with charters and voucher expansion. This will should be sent back to the drawing board and split into two, mainly since if there's supposed support for voucher expansion and charter expansion, it should be allowed to stand on its own to see how much support it would get. Same with the public-school enhancement items that were added to this bill, they should be allowed to stand on their own and see how much

support they truly have. I think people would be surprised to see which ones would have the better support. SB727, as written in its 150+ page current form, should be not allowed to continue and it should be sent back to the drawing board. I read through all of the bill text, it wasn't an easy or light read, though it's important to get the full flavor of an omnibus-sized attempt to try and get voucher expansion and charter school expansion at all costs, wrapped in amenities for public school to gain support.No thank you, we're not interested in voucher or charter expansion, not now, not ever. Fund public schools as they should be, and you'll be surprised with the results.

SB 727 is chock full of unintended consequences, many of which actually work against the concept of school choice. The first thing to note is that this bill was passed in violation of limits placed on the legislative process in Article III of the Missouri Constitution, including the single subject requirement, the prohibition of changing the original purpose of a bill through amendments, and the prohibition of passing local or special laws where a general law is possible.-- SB 727 also included provisions that are unconstitutional on their face. Subsidizing private education choices through tax credits as done in this bill violate:-- Article III, Section 36 of the Missouri Constitution, because it has the effect of "divert [ing]" money from the treasury independent of the appropriation process.-- Article III, Section 38(a) of the Missouri Constitution, which states that "The general assembly shall have no power to grant public money or property, or lend or authorize the lending of public credit, to any private person, association or corporation..."-- Article III, Section 39(5) of the Missouri Constitution because it has the effect of "releas[ing] or extinguish[ing]... without consideration... the indebtedness, liability or obligation of... [a] corporation or individual".-- Article III, Sections 21 and 23 because the purpose of the bill was changed through amendments, and the final title violates the clear title requirement.--- SB 727 expands the power of government, particularly the size and authority of DESE. DESE is the primary problem with public education, so expanding its role may be the worst thing you can do.- The most offensive result of the bill would be the intrusion of the state into private schools, including home schools. It is not clear how much that intrusion will affect even those private school families that don't accept subsidies.--- SB 727 is NOT a free market approach to education and includes a host of unintended consequences .-- Tax Credits are government subsidies on the backs of the neighbors who receive the subsidies. That is a form of socialism.-- It should be noted that the \$25 million addition to the "school choice" subsidies will only \*possibly\* help about 4/10 of one percent of the 870,000 K-12 kids in the state. (That's 0.004.) (Assuming \$6000 per student.) The tradeoff in growth of government and budget is not work that small gain, if it is a gain at all .-- It has NEVER been the conservative thing to accept "school choice" with strings attached, so SB 727 is not consistent with any conservative or Republican agenda.-- The subsidies in SB 727, like all subsidies (e.g. the student loan program for higher ed), will increase the cost of private schools. As a result, the families that don't receive the subsidies in SB 727 will face increased costs -- as a result, some of them may no longer be able to afford to send their kids to private schools.-- Although the cost is subject to debate, it looks like the cost to taxpayers will be between \$250 million and \$800 million. That increased cost will ultimately increase the tax burden of everyone, so some families currently sending their kids to private schools may no longer be able to afford it.---- Those unintended consequences will likely result in even less than the .004 increase in "school choice" kids.-----The PRINCIPLED solution to the failing government schools would include:-- For the kids stuck in the failing government schools, give back control of local schools to the people who care most about those kids - their parents. Trust them.

- Wrest back the local control that was stolen by the 1992 Senate Bill 380 – the so-called "Outstanding Schools Act."- Relegate DESE to its original role, not the central planning behemoth it has become.- Allow "portability" by preventing someone's resident school district from locking them into that district. Parents should have the option of moving their children, along with the per-pupil state funding, to any other government school that will accept them. The receiving school should have complete discretion whether to accept or reject out-of-district students. Parents are responsible for transportation.- And if you want to give home school and private school families some relief, let them keep what is theirs to start with. Any family with school age children who are not using the government schools should not have to pay school taxes.

As a former teacher who taught for 31 years in a Blue Springs public school, I would like to express my concerns and support for SS#2 SCS SB 727. I feel that it would be a tremendous mistake to encourage charter schools and to increase the empowerment scholarship amounts. Public schools educate every child who walks through the door and that education requires adequate funding, proper resources and fair compensation for quality, certified teachers. Today's teachers bring to education wonderful learning techniques that were not presented in my teaching training. Fortunately, teacher professional learning programs enhanced our understanding of diverse populations, learning styles, behavioral strategies, etc. made a tremendous difference in affecting our effectiveness. These programs require fundings to allow teachers to deal with unexpected issues that arise in today's society, and need funding. Our community was also instrumental in providing support to the educational setting, and the teachers supported community projects as well. Community members and teachers worked as a team. I also feel that accountability is vitally important, and is present in a public school system, but not required in charter schools. How many people would abide by the speed limit if there wasn't fear of a speeding ticket? My husband complained of numerous situations he encountered in his working environment where accountability wasn't enforced. The lack of accountability and oversight that could exist in charter schools would be a tremendous waste of taxpayer dollars. I am pleased with aspect of the legislation that increases the quality, accessibility and flexibility of teachers and strongly urge that teacher salaries be increased. Teaching is certainly a "labor of love" and ends up being a 24 hour job, but teachers still need to support their families and provide for the many expenses that occur with a family. A family shouldn't be penalized for having a parent in education. The retirement system in education is strong and does a great job providing secure retirement. Please keep that intact. I also strongly support funding for smaller and rural schools. Often, smaller schools offer more opportunities for a positive educational foundation. Please continue to provide them necessary funding to provide quality education. I have no issue with the districts who feel that a four day workweek works best for their population. I feel that districts should be able to make decisions that best suits their populations. Please support early childhood programs, career ladder programs, literacy programs, suicide prevention programs and other programs that address educational needs. Students become future leaders, tax pavers and voters and it is to everyone's advantage to have them as well rounded as possible with diverse public education. Thank you for letting me offer my input. I just recently had a conversation with a person from a different state who was explaining how the educational standards of that state had declined to the point where people were employed as teachers who had no teaching training and how ineffective they were being and how disinterested the students had become. We cannot let that happen in Missouri, and we are at risk of that being the case if charter schools and empowerment scholarships are given

greater funding. Please empower public schools. Thank you.
