I call on you to pass this bill out of committee. It creates the Constitution Money Act making gold acceptable legal tender and prohibiting the confiscation of gold by the government. . In addition, a cyber attack, a downed electrical grid system or some other catastrophe will wipe out our digital currency in an instant thus destroying our way of life. More on the Decline of the American Dollar Patrick Holland with the grassroots organization Missouri Freedom Initiative noted that state governments have three key concerns regarding the decline of the American dollar: Inflation continues to ravage household budgets and threatens access to essentials such as fuel and food. In July this year, the US government is expected to roll out its Central Bank Digital Currency (CBDC). With bonds bleeding over the past two years, an increasing number of states have found their pension funds in dire straits. Key points of SB735, the "Constitutional Money Act." The state should recognize gold and silver as money, both of which can be used for the purchase or repayment of debt. Precious metals shall be valued by the state at spot plus a market premium. All taxes should be eliminated on the sale of precious metals. The treasury must be willing to accept payment of state taxes in gold and silver. The treasury must maintain a minimum of 1% of operational reserves in precious metals in a special reserve or depository. Remembering Roosevelt's confiscation of gold during the Great Depression, the bill also prohibits any state agency from seizing physical gold holdings. The bill seeks to prevent the imposition of digital currency as a compulsory form of transaction. The supporters of the bill prefer to maintain optionality for the consumer. By being a hedge against inflation, precious metals protect against excesses such as unbridled spending by state authorities and huge deficits.

More on the Decline of the American Dollar Patrick Holland with the grassroots organization Missouri Freedom Initiative noted that state governments have three key concerns regarding the decline of the American dollar: Inflation continues to ravage household budgets and threatens access to essentials such as fuel and food. In July this year, the US government is expected to roll out its Central Bank Digital Currency (CBDC). With bonds bleeding over the past two years, an increasing number of states have found their pension funds in dire straits. Key points of SB735, the "Constitutional Money Act." The state should recognize gold and silver as money, both of which can be used for the purchase or repayment of debt. Precious metals shall be valued by the state at spot plus a market premium. All taxes should be eliminated on the sale of precious metals. The treasury must be willing to accept payment of state taxes in gold and silver. The treasury must maintain a minimum of 1% of operational reserves in precious metals in a special reserve or depository. Remembering Roosevelt's confiscation of gold during the Great Depression, the bill also prohibits any state agency from seizing physical gold holdings. The bill seeks to prevent the imposition of digital currency as a compulsory form of transaction. The supporters of the bill prefer to maintain optionality for the consumer. By being a hedge against inflation, precious metals protect against excesses such as unbridled spending by state authorities and huge deficits.

More on the Decline of the American Dollar Patrick Holland with the grassroots organization Missouri Freedom Initiative noted that state governments have three key concerns regarding the decline of the American dollar: Inflation continues to ravage household budgets and threatens access to essentials such as fuel and food. In July this year, the US government is expected to roll out its Central Bank Digital Currency (CBDC). With bonds bleeding over the past two years, an increasing number of states have found their pension funds in dire straits. Key points of SB735, the "Constitutional Money Act." The state should recognize gold and silver as money, both of which can be used for the purchase or repayment of debt. Precious metals shall be valued by the state at spot plus a market premium. All taxes should be eliminated on the sale of precious metals. The treasury must be willing to accept payment of state taxes in gold and silver. The treasury must maintain a minimum of 1% of operational reserves in precious metals in a special reserve or depository. Remembering Roosevelt's confiscation of gold during the Great Depression, the bill also prohibits any state agency from seizing physical gold holdings. The bill seeks to prevent the imposition of digital currency as a compulsory form of transaction. The supporters of the bill prefer to maintain optionality for the consumer. By being a hedge against inflation, precious metals protect against excesses such as unbridled spending by state authorities and huge deficits.
