It creates the Constitution Money Act making gold acceptable legal tender and prohibiting the confiscation of gold by the government. Article I section 10 of the U.S. constitution recognized state authority to issue gold. The Federal Reserve destroyed this constitutional system by issuing federal reserve notes and the U.S. abandoned the gold standard in 1971. Thus, the Federal Reserve fiat currency is not backed by anything. The federal government can just print money out of thin air thus devaluing the dollar, causing inflation, and raising the debt to unsound Fiscally responsible levels. The federal reserve banks are already using digital currency in				

their commercial transactions. The federal government and international central banks plan to introduce digital currency worldwide. Digital currency will destroy our freedom and allow the governments to control how we spend our money. In addition, a cyber attack, a downed electrical grid system or some other catastrophe will wipe out our digital currency in an instant thus destroying our way of life. Gold, on the other hand, is indestructible has retained its value over centuries. It allows for total privacy and freedom in transactions. Russia and China are buying up gold in record amounts. The BRICs nations are trading in currencies other than the U.S. dollar and backing these currencies with gold. The price of gold has spiked in April and is trading at \$2347 an ounce. Signs of the times and wisdom dictate the use of gold more and more. Gold is ideal for large transactions, and fractional gold and Gold Backs can be used for smaller transactions.

The treasury must maintain a minimum of 1% of operational reserves in precious metals in a special reserve or depository. Remembering Roosevelt's confiscation of gold during the Great Depression, the bill also prohibits any state agency from seizing physical gold holdings. The bill seeks to prevent the imposition of digital currency as a compulsory form of transaction. The supporters of the bill prefer to maintain optionality for the consumer. By being a hedge against inflation, precious metals protect against excesses such as unbridled spending by state authorities and huge deficits.
