Associated Industries of Missouri supports the ORIGINAL bill. We do not have a position on the provisions related to "specie" or the language regarding Central Bank Digital Currency and would prefer the bill be returned to only increase the amounts available for the linked deposit program through MOBUCKS. We would also point out that the bill has a technical flaw. On page 2, line 33, the bill defines "specie" as having the same meaning as in section 408.010, yet that section does not define "specie" - it only defines silver as legal tender. In fact, we could not find a definition of "specie" in current statute anywhere. We suggest returning the bill to its original form, addressing only the MOBUCKS program.
