I oppose Senate Concurrent Resolution 24. I am a Jew, I was raised Jewishin St. Louis and confirmed from B'nai El religious school. I read the Torah when I was 13 andcompleted my bar mitzvah on Masada, in Israel. I vehemently oppose this statement that is nowproposed to be issued in my name as a Missourian. Right now Israel is engaged in a campaign of massmurder and destruction against the people of Gaza. Numerous genocide scholars call it genocide. TheInternational Court of Justice has ruled that it is plausible that Israel is engaged in genocide and it hasordered Israel to stop killing people in Gaza. A federal court in California has ruled that Israel's militarycampaign in Gaza "plausibly" amounts to genocide. The racist system that Israel has in place to governall the land in its control (Israel pre-1967, the West Bank, Gaza and the Golan Heights) can beaccurately labeled Apartheid. This is according to Amnesty International and Human Rights Watch themost venerable human rights organizations on earth, as well as the Israeli human rights organizationB'Tselem.It is abhorrent for the State of Missouri to honor such a country at this time the way HCR 30honors Israel. It states that the State of Missouri supports Apartheid and genocide. It tells Palestinian-Missourians that the State of Missouri does not value them or their families. I grew up in a Zionistfamily. We supported Israel. At the time I did not know the real history and the actual reality of Israel. Ivisited myself as an adult more than once. I observed. I talked with people. My observations and discussions with people have shown me that Israel's present governance in all the territory under its control is blatantly oppressive. Specifically, it grants rights to Jews that are denied to Palestinians. This arrangement is not just and not democratic.In addition to being raised Zionist I was raised withAmerican values. I was raised to respect the rights of all people. As an American, I was taught that allpeople should have equal rights regardless of their race, religion or ethnicity. Because of the valuestaught to me by my parents, I feel the moral duty to oppose discrimination that is carried out in myname, by a state that claims to act on my behalf. I believe that American values are in contradiction to Zionist values. That is why it creates so much pain to see the State of Missouri consider this resolution. This resolution tightly ties America to the State of Israel and this is a bad thing. I testify forthe over 10,000 children killed by Israel since October, the over 20,000 adults, and the two millionpeople now homeless and hungry in Gaza. I testify for the children whose homes and possession are being ransacked right now by Israeli troops. I testify for the family of friends of mine whosegrandmothers, grandfathers, brothers, sisters, in-laws, and nephews have recently been killed by sraeli bombs. I testify for Palestinian children who, trapped behind a giant wall in the West Bank, cansee the sea from their homes on hills but have never been allowed to touch its water. I do this for theelderly men and women who witness their home and the olive trees they have tended to their entirelives destroyed before their eyes by religious fanatic settlers. I do this for the shepherd who isseparated from his sheep by a deadly electrified fence. I do this for my friends who have spent years inIsraeli prisons after never receiving a fair trial. I do this for so many others who have been killed bylsraeli soldiers in my name, in their own homes, in their own cities and villages. This

resolution alsooffends me for making theological statements with which I do not agree. I do not agree that God has given those who now adhere to Judaism and those of Jewish ancestry the exclusive right to dowhatever they want to a section of the earth and the other people who live there. I do not believe thatGod has given special rights to certain people at the expense of other people. I don't believe in anexclusive, racist God. I don't believe that this is the proper interpretation of Jewish tradition orChristian tradition. Some people do believe this - lets keep this a theological debate and not express itas a proclamation of the State of Missouri. The resolution also names Jerusalem as the "eternal capitalof Israel". I very much disagree with the decision of the United States to recognize Jerusalem as thecapital of Israel, as it unnecessarily exacerbates tensions and helps legitimize Israel's illegalannexation of land in East Jerusalem. But if the State of Missouri were to say that it supports therecognition of Jerusalem as the capital of Israel, that would at least be a comment on policy.Recognizing Jerusalem as the "eternal capital of Israel" is a statement that only makes sense as atheological statement. Jerusalem is a beautiful city. But there was a time that it did not exist, and in thefuture, there will be a time that it does not exist. There will be a time in the future that Israel does notexist. All countries, all states, all empires - they eventually fall. Even Rome fell.Outside of a theological context, naming any capital as an "eternal capital" is patently absurd. Would we name Jefferson City"the eternal capital of Missouri" or Clayton "the eternal county seat of St. Louis County"? We wouldnot and we should not. We should not name Jerusalem the "eternal capital of Israel". Please reject this vile resolution which contains dubious theology and directly links the State of Missouri with policies of Apartheid and genocide.
