1 AMEND House Bill No. 366, Page 1, Section A, Line 2, by inserting after all of said section and
2 line the following:
3

4 "338.015. 1. The provisions of sections 338.010 to 338.015 shall not be construed to inhibit
5 the patient's freedom of choice to obtain prescription services from any licensed pharmacist or
6 pharmacy. However, nothing in sections 338.010 to 338.315 abrogates the patient's ability to waive
7 freedom of choice under any contract with regard to payment or coverage of prescription expense.

8 2. All pharmacists may provide pharmaceutical consultation and advice to persons
9 concerning the safe and therapeutic use of their prescription drugs.

10 3. All patients shall have the right to receive a written prescription from their prescriber to
11 take to the facility of their choice or to have an electronic prescription transmitted to the facility of
12 their choice.

13 4. No pharmacy benefits manager, as defined in section 376.388, shall prohibit or redirect
14 by contract, or otherwise penalize or restrict, a covered person, as defined in section 376.387, from
15 obtaining any of the following from a contracted pharmacy, as defined in section 376.388:

16 (1) Prescription services, including all prescriptions covered by the covered person's health
17 benefit plan;

18 (2) Consultation; or

19 (3) Advice.

20 376.387. 1. For purposes of this section, the following terms shall mean:

21 (1) "Covered person", ~~[the same meaning as such term is defined in section 376.1257]~~ a
22 policyholder, subscriber, enrollee, or other individual whose prescription drug coverage is
23 administered through a pharmacy benefits manager or a health benefit plan;

24 (2) "Health benefit plan", the same meaning as such term is defined in section 376.1350;

25 (3) "Health carrier" or "carrier", the same meaning as such term is defined in section
26 376.1350;

27 (4) "Pharmacy", the same meaning as such term is defined in chapter 338;

28 (5) "Pharmacy benefits manager", the same meaning as such term is defined in section
29 376.388;

(6) "Pharmacy benefits manager rebate aggregator", any entity that negotiates with a pharmaceutical manufacturer on behalf of a pharmacy benefits manager for a rebate;

(7) "Pharmacy claims data", information regarding a prescription transaction that is adjudicated by a pharmacy benefits manager for a covered person between the pharmacy and the pharmacy benefits manager and between the pharmacy benefits manager and the health benefit plan sponsor;

(8) "Rebate", any discount, negotiated concession, or other payment provided by a pharmaceutical manufacturer, pharmacy, or health benefit plan to an entity to sell, provide, pay, or reimburse a pharmacy or other entity in the state for the dispensation, coverage, or administration of a prescription drug on behalf of itself or another entity.

2. No pharmacy benefits manager shall ~~[include a provision in a contract entered into or modified on or after August 28, 2018, with a pharmacy or pharmacist that requires]~~ require a covered person to make a payment for a prescription drug at the point of sale in an amount that exceeds the lesser of:

(1) The copayment amount as required under the health benefit plan; ~~[or]~~

(2) The amount an individual would pay for a prescription if that individual paid with cash;
or

(3) The amount equal to the difference of the final reimbursement amount paid to the contracted pharmacy, as defined in section 376.388, by the pharmacy benefits manager for the prescription drug minus any rebate paid, and any amount paid or owed by the health benefit plan, for the prescription drug.

3. A pharmacy or pharmacist shall have the right to:

(1) Provide to a covered person information regarding the amount of the covered person's cost share for a prescription drug, the covered person's cost of an alternative drug, and the covered person's cost of the drug without adjudicating the claim through the pharmacy benefits manager. Neither a pharmacy nor a pharmacist shall be proscribed by a pharmacy benefits manager from discussing any such information or from selling a more affordable alternative to the covered person;
and

(2) Provide to a health benefit plan sponsor any information, including pharmacy claims data, related to the sponsor's health benefit plan except to the extent prohibited by law.

4. (1) A pharmacy benefits manager shall not directly or indirectly, including indirectly through a pharmacy services administrative organization, reduce the amount of an individual claim or an aggregation of claims at the time of the adjudication of the claim or aggregation of claims or after the claim or aggregation of claims is adjudicated.

(2) A pharmacy benefits manager shall not directly or indirectly, including indirectly through a pharmacy services administrative organization, charge a pharmacy a fee related to the adjudication of a claim, including any fee related to:

(a) The receipt and processing of a pharmacy claim;

(b) The development or management of a claim processing or adjudication network; or

1 (c) Participation in a claim processing or claim adjudication network.

2 5. No pharmacy benefits manager shall, directly or indirectly, charge or hold a pharmacist or
 3 pharmacy responsible for any fee amount related to a claim that is not known at the time of the
 4 claim's adjudication, unless the amount is a result of improperly paid claims [or charges for
 5 administering a health benefit plan].

6 ~~[5. This section shall not apply with respect to claims under Medicare Part D, or any other~~
 7 ~~plan administered or regulated solely under federal law, and to the extent this section may be~~
 8 ~~preempted under the Employee Retirement Income Security Act of 1974 for self-funded employer-~~
 9 ~~sponsored health benefit plans.]~~

10 6. A pharmacy benefits manager shall notify in writing any health carrier with which it
 11 contracts if the pharmacy benefits manager has a conflict of interest, any commonality of
 12 ownership, or any other relationship, financial or otherwise, between the pharmacy benefits manager
 13 and any other health carrier with which the pharmacy benefits manager contracts.

14 7. Any pharmacy benefits manager that enters into a contract to sell, provide, pay, or
 15 reimburse a pharmacy in the state for prescription drugs on behalf of itself or another entity shall
 16 define and apply the term "generic", with respect to prescription drugs, to mean any "authorized
 17 generic drug", as defined in 21 CFR 314.3, approved under Section 505(c) of the Federal Food,
 18 Drug, and Cosmetic Act, as amended.

19 8. An entity shall define and apply the term "rebate" as having the same meaning given to
 20 the term in this section if the entity enters into a contract to sell, provide, pay, negotiate rebates for,
 21 or reimburse a pharmacy, pharmacy benefits manager, pharmacy benefits manager affiliate as
 22 defined in section 376.388, or pharmacy benefits manager rebate aggregator for prescription drugs
 23 on behalf of itself or another entity.

24 9. A pharmacy benefits manager that has contracted with an entity to provide pharmacy
 25 benefits management services for such an entity or any person who negotiates with a pharmacy
 26 benefits manager on behalf of a purchaser of health care benefits shall owe a fiduciary duty to that
 27 entity or purchaser of health care benefits and shall discharge that duty in accordance with federal
 28 and state law.

29 10. A pharmacy benefits manager shall have a duty to disclose to a health benefit plan
 30 sponsor. As used in this subsection, "duty to disclose" shall mean notifying the health benefit plan
 31 sponsor of material facts and actions taken by a pharmacy benefits manager related to the
 32 administration of the pharmacy benefits on behalf of the health benefit plan sponsor that:

33 (1) May increase costs to the sponsor or its covered persons as compared to a more prudent
 34 action that could be taken; or

35 (2) Present a conflict of interest between the interests of the sponsor and its covered persons
 36 and the interests of the pharmacy benefits manager.

37 11. Any entity that enters into a contract to sell, provide, pay, or reimburse a pharmacy in
 38 the state for prescription drugs on behalf of itself or another entity shall not prohibit a health benefit

1 plan sponsor and a participating pharmacy from discussing any health benefit plan information,
 2 including pharmacy claims data or costs.

3 12. The department of commerce and insurance shall enforce this section.

4 376.388. 1. As used in this section, unless the context requires otherwise, the following
 5 terms shall mean:

6 (1) "Contracted pharmacy" [~~or "pharmacy"~~], a pharmacy located in Missouri participating in
 7 the network of a pharmacy benefits manager through a direct or indirect contract;

8 (2) [~~"Health carrier", an entity subject to the insurance laws and regulations of this state that~~
 9 ~~contracts or offers to contract to provide, deliver, arrange for, pay for, or reimburse any of the costs~~
 10 ~~of health care services, including a sickness and accident insurance company, a health maintenance~~
 11 ~~organization, a nonprofit hospital and health service corporation, or any other entity providing a plan~~
 12 ~~of health insurance, health benefits, or health services, except that such plan shall not include any~~
 13 ~~coverage pursuant to a liability insurance policy, workers' compensation insurance policy, or~~
 14 ~~medical payments insurance issued as a supplement to a liability policy;~~

15 (3)] "Maximum allowable cost", the per-unit amount that a pharmacy benefits manager
 16 reimburses a pharmacist for a prescription drug, excluding a dispensing or professional fee;

17 [(4)] (3) "Maximum allowable cost list" or "MAC list", a listing of drug products that meet
 18 the standard described in this section;

19 [(5)] (4) "Pharmacy", as such term is defined in chapter 338;

20 [(6)] (5) "Pharmacy benefits manager", an entity that contracts with pharmacies on behalf of
 21 health carriers [~~or any health plan sponsored by the state or a political subdivision of the state~~] or
 22 health benefit plans to provide prescription drug and pharmacist services;

23 (6) "Pharmacy benefits manager affiliate", a pharmacy or pharmacist that directly or
 24 indirectly, through one or more intermediaries, owns or controls, is owned or controlled by, or is
 25 under common ownership or control with a pharmacy benefits manager.

26 2. Upon each contract execution or renewal between a pharmacy benefits manager and a
 27 pharmacy or between a pharmacy benefits manager and a pharmacy's contracting representative or
 28 agent, such as a pharmacy services administrative organization, a pharmacy benefits manager shall,
 29 with respect to such contract or renewal:

30 (1) Include in such contract or renewal the sources utilized to determine maximum
 31 allowable cost and update such pricing information at least every seven days; and

32 (2) Maintain a procedure to eliminate products from the maximum allowable cost list of
 33 drugs subject to such pricing or modify maximum allowable cost pricing at least every seven days,
 34 if such drugs do not meet the standards and requirements of this section, in order to remain
 35 consistent with pricing changes in the marketplace.

36 3. A pharmacy benefits manager shall reimburse pharmacies for drugs subject to maximum
 37 allowable cost pricing that has been updated to reflect market pricing at least every seven days as set
 38 forth under subdivision (1) of subsection 2 of this section.

1 4. A pharmacy benefits manager shall not place a drug on a maximum allowable cost list
2 unless there are at least two therapeutically equivalent multisource generic drugs, or at least one
3 generic drug available from at least one manufacturer, generally available for purchase by network
4 pharmacies from national or regional wholesalers.

5 5. (1) All contracts between a pharmacy benefits manager and a contracted pharmacy or
6 between a pharmacy benefits manager and a pharmacy's contracting representative or agent, such as
7 a pharmacy services administrative organization, shall include a process to internally appeal,
8 investigate, and resolve disputes regarding maximum allowable cost pricing. The process shall
9 include the following:

10 ~~[(1)]~~ (a) The right to appeal shall be limited to fourteen calendar days following the
11 reimbursement of the initial claim; and

12 ~~[(2)]~~ (b) A requirement that the pharmacy benefits manager shall respond to an appeal
13 described in this subsection no later than fourteen calendar days after the date the appeal was
14 received by such pharmacy benefits manager.

15 (2) If a reimbursement to a contracted pharmacy is below the pharmacy's cost to purchase
16 the drug, the pharmacy may decline to dispense the prescription. A pharmacy benefits manager
17 shall not prohibit a pharmacy from declining to dispense a drug for such reason or otherwise
18 retaliate against a pharmacy for doing so.

19 (3) A pharmacy benefits manager shall not:

20 (a) Pay or reimburse a pharmacy or pharmacist in the state an amount less than the amount
21 that the pharmacy benefits manager reimburses a pharmacy benefits manager affiliate for providing
22 the same products and pharmacist services, which amount shall be calculated on a per-unit basis
23 using the same generic product identifier or generic code number;

24 (b) Pay or reimburse a pharmacy or pharmacist in the state for the ingredient drug product
25 component of pharmacist services less than the national average drug acquisition cost or, if the
26 national average drug acquisition cost is unavailable, the wholesale acquisition cost;

27 (c) Make or permit any reduction of payment for pharmacist services by a pharmacy
28 benefits manager or a health care payer directly or indirectly to a pharmacy under a reconciliation
29 process to an effective rate of reimbursement including, but not limited to, generic effective rates,
30 brand effective rates, direct and indirect remuneration fees, or any other reduction or aggregate
31 reduction of payment; or

32 (d) Remove from any pharmacy its legal right to civil recourse including, but not limited to,
33 requiring a pharmacy to use arbitration to settle grievances.

34 6. For appeals that are denied, the pharmacy benefits manager shall provide the reason for
35 the denial and identify the national drug code of a drug product that may be purchased by contracted
36 pharmacies at a price at or below the maximum allowable cost and, when applicable, may be
37 substituted lawfully.

38 7. If the appeal is successful, the pharmacy benefits manager shall:

(1) Adjust the maximum allowable cost price that is the subject of the appeal effective on the day after the date the appeal is decided;

(2) Apply the adjusted maximum allowable cost price to all similarly situated pharmacies as determined by the pharmacy benefits manager; and

(3) Allow the pharmacy that succeeded in the appeal to reverse and rebill the pharmacy benefits claim giving rise to the appeal.

8. Appeals shall be upheld if:

(1) The pharmacy being reimbursed for the drug subject to the maximum allowable cost pricing in question was not reimbursed as required under subsection 3 of this section; or

(2) The drug subject to the maximum allowable cost pricing in question does not meet the requirements set forth under subsection 4 of this section.

376.448. 1. As used in this section, the following terms mean:

(1) "Cost-sharing", any co-payment, coinsurance, deductible, amount paid by an enrollee for health care services in excess of a coverage limitation, or similar charge required by or on behalf of an enrollee in order to receive a specific health care service covered by a health benefit plan, whether covered under medical benefits or pharmacy benefits. The term "cost-sharing" shall include cost-sharing as defined in 42 U.S.C. Section 18022(c);

(2) "Enrollee", the same meaning given to the term in section 376.1350;

(3) "Health benefit plan", the same meaning given to the term in section 376.1350;

(4) "Health care service", the same meaning given to the term in section 376.1350;

(5) "Health carrier", the same meaning given to the term in section 376.1350;

(6) "Pharmacy benefits manager", the same meaning given to the term in section 376.388.

2. When calculating an enrollee's overall contribution to any out-of-pocket maximum or any cost-sharing requirement under a health benefit plan, a health carrier or pharmacy benefits manager shall include any amounts paid by the enrollee or paid on behalf of the enrollee for any medication where a generic substitute for such medication is not available.

3. A health carrier or pharmacy benefits manager shall not vary an enrollee's out-of-pocket maximum or any cost-sharing requirement based on, or otherwise design benefits in a manner that takes into account, the availability of any cost-sharing assistance program for any medication where a generic substitute for such medication is not available.

4. If, under federal law, application of the requirement under subsection 2 of this section would result in health savings account ineligibility under Section 223 of the Internal Revenue Code of 1986, as amended, the requirement under subsection 2 of this section shall apply to health savings account-qualified high deductible health plans with respect to any cost-sharing of such a plan after the enrollee has satisfied the minimum deductible under Section 223, except with respect to items or services that are preventive care under Section 223(c)(2)(C) of the Internal Revenue Code of 1986, as amended, in which case the requirement of subsection 2 of this section shall apply regardless of whether the minimum deductible under Section 223 has been satisfied.

1 5. Nothing in this section shall prohibit a health carrier or health benefit plan from utilizing
2 step therapy in accordance with section 376.2034.

3 6. The provisions of this section shall not apply to health benefit plans that are covered
4 under the Labor Management Relations Act of 1947, 29 U.S.C. Section 141 et seq., as amended.";
