1 AMEND House Committee Substitute for Senate Substitute for Senate Bill No. 61, Pages 9-11,
2 Section 334.031, Lines 1-66, by deleting all of said lines and inserting in lieu thereof the following:

4 "334.031. 1. Candidates for licenses as physicians and surgeons shall furnish [satisfactory
5 evidence of their good moral character, and their preliminary qualifications, to wit: a certificate of
6 graduation from an accredited high school or its equivalent, and satisfactory evidence of completion
7 of preprofessional education consisting of a minimum of sixty semester hours of college credits in
8 acceptable subjects leading towards the degree of bachelor of arts or bachelor of science from an
9 accredited college or university. They shall also furnish satisfactory evidence of having attended
10 throughout at least four terms of thirty-two weeks of actual instructions in each term and of having
11 received a diploma from some reputable medical college or osteopathic college that enforces
12 requirements of four terms of thirty-two weeks for actual instruction in each term, including, in
13 addition to class work, such experience in operative and hospital work during the last two years of
14 instruction as is required by the American Medical Association and the American Osteopathic
15 Association before the college is approved and accredited as reputable. Any medical college
16 approved and accredited as reputable by the American Medical Association or the Liaison
17 Committee on Medical Education and any osteopathic college approved and accredited as reputable
18 by the American Osteopathic Association is deemed to have complied with the requirements of this
19 subsection];

20 (1) Evidence of good moral character by submitting to a criminal background check as
21 provided in section 43.540;

22 (2) A diploma and academic transcripts from a school accredited by the Liaison Committee
23 on Medical Education, the Commission on Osteopathic College Accreditation, the Educational
24 Commission for Foreign Medical Graduates (ECFMG), or a similar accrediting agency; and

25 (3) A certificate demonstrating that the applicant has satisfied the requirements of section
26 334.035.

27 2. In determining the qualifications necessary for licensure as a qualified physician and
28 surgeon, the board, by rule and regulation, may accept the certificate of the National Board of
29 Medical Examiners of the United States, chartered pursuant to the laws of the District of Columbia,
30 of the National Board of Examiners for Osteopathic Physicians and Surgeons chartered pursuant to

1 the laws of the state of Indiana, or of the Licentiate of the Medical Counsel of Canada (LMCC) in
2 lieu of and as equivalent to its own professional examination. Every applicant for a license on the
3 basis of such certificate, upon making application showing necessary qualifications as provided in
4 subsection 1 of this section, shall be required to pay the same fee required of applicants to take the
5 examination before the board.

6 3. The board may require applicants to list all licenses to practice as a physician currently or
7 previously held in any other state, territory, or country and to disclose any past or pending
8 investigations, discipline, or sanctions against each such license.

9 4. In addition to the criminal background screening required by this section, the board may
10 obtain a report on the applicant from the National Practitioner Data Bank or the Federation of State
11 Medical Boards."; and

13 Further amend said bill, Pages 11-12, Section 334.035, Lines 1-28, by removing all of said section
14 and lines from the bill; and

16 Further amend said bill by amending the title, enacting clause, and intersectional references
17 accordingly.
