1 AMEND House Committee Substitute for Senate Bill No. 189, Page 15, Section 168.071, Line 116,
2 by inserting after said section and line the following:

4 "170.027. 1. This section shall be known and may be cited as the "Missouri Integrated Safe
5 Driving Program".

6 2. As used in this section, "driver education instruction and training" means instruction and
7 training provided under the Missouri integrated safe driving program that offers instruction in the
8 use and operation of motor vehicles including, but not limited to, instruction in the safe operation of
9 motor vehicles and rules of the road and the laws of this state relating to motor vehicles.

10 3. (1) The state department of elementary and secondary education shall receive and vet
11 sample lessons from recognized statewide professional organizations and districts that meet the
12 requirements of the Missouri integrated safe driving program.

13 (2) Sample lessons shall be made available to each public school district and charter school
14 offering courses to pupils in grades nine through twelve.

15 (3) For the 2026-27 school year and all subsequent school years, each public school district
16 and charter school offering courses to pupils in grades nine through twelve may adopt a plan
17 implementing the Missouri integrated safe driving program, which may use the sample lessons.

18 4. The Missouri integrated safe driving program shall:

19 (1) Inform pupils about the requirements for obtaining and driving with an instruction
20 permit, an intermediate license, and a full driver license under Missouri's graduated driver license
21 law as established in chapter 302;

22 (2) Emphasize the development of knowledge, attitudes, habits, and skills necessary for the
23 safe operation of motor vehicles;

24 (3) Provide instruction on distracted driving as a major traffic safety issue;

25 (4) Provide instruction concerning law enforcement procedures for traffic stops, including a
26 demonstration of the proper actions to be taken during a traffic stop and appropriate interactions
27 with law enforcement; and

28 (5) Provide pupils with current data on driver safety related to risky behaviors.

29 5. Districts may require pupils to participate in lessons devoted to addressing the
30 requirements of the Missouri integrated safe driving program in courses as determined by the

1 district. These lessons shall meet standards within the content of the course but use safe driving as
2 the context and application of the course standards.

3 6. (1) The driver education instruction and training under this section shall not require any
4 pupil to physically operate a motor vehicle as part of such instruction and training.

5 (2) This section shall not be construed to prohibit any public school district or charter school
6 from offering an elective driver education course that is different from the driver education
7 instruction and training required under this section.

8 7. The state board of education may promulgate all necessary rules and regulations for the
9 administration of this section. Any rule or portion of a rule, as that term is defined in section
10 536.010, that is created under the authority delegated in this section shall become effective only if it
11 complies with and is subject to all of the provisions of chapter 536 and, if applicable, section
12 536.028. This section and chapter 536 are nonseverable and if any of the powers vested with the
13 general assembly pursuant to chapter 536 to review, to delay the effective date, or to disapprove and
14 annul a rule are subsequently held unconstitutional, then the grant of rulemaking authority and any
15 rule proposed or adopted after the effective date of this section shall be invalid and void."; and

17 Further amend said bill by amending the title, enacting clause, and intersectional references
