1 2 3	AMEND House Committee Substitute for Senate Bill No. 189, Page 50, Section 304.022, Line 74, by inserting after said section and line the following:
4	"304.281. 1. Whenever traffic is controlled by traffic control signals exhibiting different
5	colored lights, or colored lighted arrows, successively one at a time or in combination, only the
6	colors green, red and yellow shall be used, except for special pedestrian signals carrying a word
7 8	legend, and said lights shall indicate and apply to drivers of vehicles and pedestrians as follows: (1) Green indication
9	(a) Vehicular traffic facing a circular green signal may proceed straight through or turn righ
10	or left unless a sign at such place prohibits either such turn. But vehicular traffic, including vehicles
11	turning right or left, shall yield the right-of-way to other vehicles and to pedestrians lawfully within
12	the intersection or an adjacent crosswalk at the time such signal is exhibited;
13	(b) Vehicular traffic facing a green arrow signal, shown alone or in combination with
14	another indication, may cautiously enter the intersection only to make the movement indicated by
15	such arrow, or such other movement as is permitted by other indications shown at the same time.
16	Such vehicular traffic shall yield the right-of-way to pedestrians lawfully within an adjacent
17	crosswalk and to other traffic lawfully using the intersection;
18	(c) Unless otherwise directed by a pedestrian control signal, as provided in section 304.291
19	pedestrians facing any green signal, except when the sole green signal is a turn arrow, may proceed
20	across the roadway within any marked or unmarked crosswalk.
21	(2) Steady yellow indication
22	(a) Vehicular traffic facing a steady yellow signal is thereby warned that the related green
23	movement is being terminated or that a red indication will be exhibited immediately thereafter whe
24	vehicular traffic shall not enter the intersection;
25	(b) Pedestrians facing a steady yellow signal, unless otherwise directed by a pedestrian
26	control signal as provided in section 304.291, are thereby advised that there is insufficient time to
27	cross the roadway before a red indication is shown and no pedestrian shall then start to cross the
28	roadway.
29	(3) Steady red indication

(a) Vehicular traffic facing a steady red signal alone shall stop before entering the crosswalk
 on the near side of the intersection at a clearly marked stop line but, if none, then before entering the
 intersection and shall remain standing until an indication to proceed is shown except as provided in
 paragraph (b);

5 (b) The driver of a vehicle which is stopped as close as practicable at the entrance to the 6 crosswalk on the near side of the intersection or, if none, then at the entrance to the intersection in 7 obedience to a red signal, may cautiously enter the intersection to make a right turn but shall yield 8 the right-of-way to pedestrians and other traffic proceeding as directed by the signal at the 9 intersection, except that the state highways and transportation commission with reference to an 10 intersection involving a state highway, and local authorities with reference to an intersection involving other highways under their jurisdiction, may prohibit any such right turn against a red 11 12 signal at any intersection where safety conditions so require, said prohibition shall be effective when 13 a sign is erected at such intersection giving notice thereof;

(c) Unless otherwise directed by a pedestrian control signal as provided in section 304.291,
 pedestrians facing a steady red signal alone shall not enter the roadway.

(4) In the event an official traffic control signal is erected and maintained at a place other
than an intersection, the provision of this section shall be applicable except as to those provisions
which by their nature can have no application. Any stop required shall be made at a sign or marking
on the pavement indicating where the stop shall be made, but in the absence of any such sign or
marking the stop shall be made at the signal.

2. Notwithstanding the provisions of section 304.361, violation of this section is a [class C]
 <u>class B</u> misdemeanor, except that violation of this section shall be a class A misdemeanor when a
 pedestrian is struck by a vehicle operated in violation of this section."; and
