 and 115.593, the election authority shall cause legal notice of each election held in its jurisdiction to

1 be published. The notice shall be published in two newspapers of different political faith and

- 2 qualified pursuant to chapter 493 which are published within the bounds of the area holding the
- 3 election. If there is only one so-qualified newspaper, then notice shall be published in only one
- 4 newspaper. If there is no newspaper published within the bounds of the election area, then the
- 5 notice shall be published in two qualified newspapers of different political faith serving the area.
- 6 Notice shall be published twice, the first publication occurring in the second week prior to the

- 1 (2) The following steps shall be taken to establish a voter's eligibility to vote at a polling 2 place:
- 3 (a) The election judge shall examine the precinct register as provided in section 115.425. If
 4 the voter is registered and eligible to vote at the polling place, the voter shall receive a regular
 5 ballot;

6 (b) If the voter's eligibility cannot be immediately established by examining the precinct 7 register, the election judge shall contact the election authority. 5. (1) Prior to counting any provisional ballot, the election authority shall determine if the
voter is registered and eligible to vote and if the vote was properly cast. The eligibility of
provisional votes shall be determined according to the requirements for a voter to cast a ballot in the
election as set forth in sections 115.133 and 115.135. A provisional [voter] ballot shall not be
eligible to be counted until the election authority has determined that:

- (a) The voter cast such provisional ballot at a polling place established for the voter or the
 central polling place established by the election authority under subsection 5 of section 115.115;
- (b) The individual who cast the provisional ballot is an individual registered to vote in the
 respective election at the polling place where the ballot was cast;

5 (2) When the ballot boxes are delivered to the election authority from the polling places, the 6 receiving teams shall separate the provisional ballots from the rest of the ballots and place the sealed 7 provisional ballot envelopes in a separate container. Teams of election authority employees or 8 teams of election judges with each team consisting of one member of each major political party 9 shall photocopy each provisional ballot envelope, such photocopy to be used by the election 10 authority to determine provisional voter eligibility. The sealed provisional ballot envelopes shall be 11 placed by the team in a sealed container and shall remain therein until tabulation.

12 (3) To determine whether a provisional ballot is valid and entitled to be counted, the election 13 authority shall examine its records and verify that the provisional voter is properly registered and 14 eligible to vote in the election. If the provisional voter has provided information regarding the 15 registration agency where the provisional voter registered to vote, the election authority shall make 16 an inquiry of the registration agency to determine whether the provisional voter is properly 17 registered and eligible to vote in the election.

- (4) If the election authority determines that the provisional voter is registered and eligible to
 vote in the election, the election authority shall provide documentation verifying the voter's
 eligibility. Such documentation shall be noted on the copy of the provisional ballot envelope and

(5) The local election authority shall record on a provisional ballot acceptance/rejection list

 to vote in the election, the election authority shall provide documentation verifying the voter's
- 30 ineligibility. Such documentation shall be noted on the copy of the provisional ballot envelope and

(a) The name of the provisional voter;

- 36 (7) The local election authority shall record on a provisional ballot acceptance/rejection list
 37 the provisional ballot identification number and notation marking it as rejected.
- 38 (8) If rejected, a photocopy of the envelope shall be made and used by the election authority
 39 as a mail-in voter registration. The actual provisional ballot envelope shall be kept as ballot

material, and the copy of the envelope shall be used by the election authority for registration recordkeeping.

3 6. All provisional ballots cast by voters whose eligibility has been verified as provided in 4 this section shall be counted in accordance with the rules governing ballot tabulation. Provisional 5 ballots shall not be counted until all provisional ballots are determined either eligible or ineligible and all provisional ballots must be processed before the election is certified. The provisional ballot 6 7 shall be counted only if the election authority determines that the voter is registered and eligible to 8 vote. Provisional ballots voted in the wrong polling place shall not be counted. 7. (1) After the election authority completes its review of the provisional voter's eligibility 11 12 under subsection 5 of this section, the election authority shall deliver the provisional ballots and 13 copies of the provisional ballot envelopes that include eligibility information to bipartisan counting 14 teams, which may be the board of verification, for review and tabulation. The election authority 15 shall maintain a record of such delivery. The record shall include the number of ballots delivered to 16 each team and shall include a signed receipt from two judges, one from each major political party. 17 The election authority shall provide each team with a ballot box and material necessary for 18 tabulation.

(2) If the person named on the provisional ballot affidavit is found to have been properly
qualified and registered to cast a ballot in the election and the provisional ballot otherwise qualifies
to be counted under the provisions of this section, the envelope shall be opened, and the ballot shall
be placed in a ballot box to be counted.

(3) If the person named on the provisional ballot affidavit is found not to have been properly
qualified and registered to cast a ballot in the election or if the election authority is unable to
determine such person's right to vote, the envelope containing the provisional ballot shall not be
opened, and the person's vote shall not be counted. The members of the team shall follow the
procedures set forth in subsection 5 of this section for rejected provisional ballots.

28 (4) The votes shall be tallied and the returns made as provided in sections 115.447 to 115.525 for paper ballots. After the vote on all ballots assigned to a team have been counted, the 29 30 ballots, ballot envelopes, and copies of ballot envelopes with the eligibility information provided by 31 the election authority shall be enclosed in sealed containers marked "Voted provisional ballots and 32 ballot envelopes from the election held , 20 ". All rejected provisional ballots, ballot 33 envelopes, and copies of ballot envelopes with the eligibility information provided by the election 34 authority shall be enclosed in sealed containers marked "Rejected provisional ballots and ballot envelopes from the election held , 20 ". On the outside of each voted ballot and 35 36 rejected ballot container, each member of the team shall write their name and all such containers 37 shall be returned to the election authority. Upon receipt of the returns and ballots, the election 38 authority shall tabulate the provisional votes.

8. Challengers and watchers, as provided by sections 115.105 and 115.107, may be present 1 2 during all times that the bipartisan counting teams are reviewing or counting the provisional ballots, 3 the provisional ballot envelopes, or copies of the provisional ballot envelopes that include eligibility 4 information provided by the election authority. Challengers and watchers shall be permitted to 5 observe the determination of the eligibility of all provisional ballots. The election authority shall notify the county chair of each major political party of the time and location when bipartisan 6 7 counting teams will be reviewing or counting the provisional ballots, the provisional ballot 8 envelopes, or the copies of the provisional ballot envelopes that include the eligibility information 9 provided by the election authority.

9. The certificate of ballot cards shall:

(1) Reflect the number of provisional envelopes delivered; and

12 (2) Reflect the number of sealed provisional envelopes with voted ballots deposited in the13 ballot box.

14 10. In counties where the voting system does not utilize a paper ballot, the election authority15 shall provide the appropriate provisional ballots to each polling place.

16 11. The secretary of state may promulgate rules for purposes of ensuring the uniform
application of this section. No rule or portion of a rule promulgated pursuant to the authority of this
section shall become effective unless it has been promulgated pursuant to chapter 536.

19 12. The secretary of state shall design and provide to the election authorities the envelopes20 and forms necessary to carry out the provisions of this section.

21 13. Pursuant to the Help America Vote Act of 2002, the secretary of state shall ensure a free 22 access system is established, such as a toll-free number or an internet website, that any individual 23 who casts a provisional ballot may access to discover whether the vote of that individual was 24 counted, and, if the vote was not counted, the reason that the vote was not counted. At the time an 25 individual casts a provisional ballot, the election authority shall give the voter written information 26 that states that any individual who casts a provisional ballot will be able to ascertain under such free 27 access system whether the vote was counted, and if the vote was not counted, the reason that the 28 vote was not counted.

In accordance with the Help America Vote Act of 2002, any individual who votes in an election as a result of a court order or any other order extending the time established for closing the polls in section 115.407 may vote only by using a provisional ballot, and such provisional ballot shall be separated and held apart from other provisional ballots cast by those not affected by the order. Such ballots shall not be counted until such time as the ballots are determined to be valid. No state court shall have jurisdiction to extend the polling hours established by law, including section 115.407.

115.453. Election judges shall count votes for all candidates in the following manner:

(1) No candidate shall be counted as voted for, except a candidate before whose name a

14 (4) Write-in votes shall be counted only for candidates for election to office who have filed 15 a declaration of intent to be a write-in candidate for election to office with the proper election authority, who shall then notify the proper filing officer of the write-in candidate prior to 5:00 p.m. 16 17 on the second Friday immediately preceding the election day; except that, write-in votes shall be 18 counted only for candidates for election to state or federal office who have filed a declaration of 19 intent to be a write-in candidate for election to state or federal office with the secretary of state pursuant to section 115.353 prior to 5:00 p.m. on the second Friday immediately preceding the 20 21 election day. No person who filed as a party or independent candidate for nomination or election to 22 an office may, without withdrawing as provided by law, file as a write-in candidate for election to 23 the same office for the same term. No candidate who files for nomination to an office and is not 24 nominated at a primary election may file a declaration of intent to be a write-in candidate for the same office at the general election. When declarations are properly filed with the secretary of state, 25 26 the secretary of state shall promptly transmit copies of all such declarations to the proper election authorities for further action pursuant to this section. The election authority shall furnish a list to the 27 28 election judges and counting teams prior to election day of all write-in candidates who have filed such declaration. (5) Bringing into this state any nonresident person with intent that such person shall vote atan election without possessing the requisite qualifications;
