AMEND House Bill No. 431, Page 3, Section 2, Line 38, by inserting after said section and line the following:
"Section 3. 1. The governor is hereby authorized and empowered to sell, transfer, grant,
convey, remise, release, and forever quitclaim all interest of the state of Missouri in property located
in Miller County, Missouri, to the City of Osage Beach, Camden County, Missouri. The property to
be conveyed is more particularly described as follows:
A tract of land for Lee C. Fine Memorial Airport in the State of Missouri and County of

23	thence South 67 degrees 57 minutes West, a distance of 231.08 feet to said northwesterly
24	Airport boundary; thence along said boundary, North 37 degrees 06 minutes 20 seconds East,
25	a distance of 97.52 feet to the true point of beginning.
26	ALSO RESERVING from said Airport tract a nonexclusive, permanent easement described
27	as commencing at the previously referenced Aluminum Pipe Monument marking the Quarter
28	Section corner between Sections 22 and 23; thence along the section line between said
29	Sections 22 and 23, South 00 degrees 42 minutes 50 seconds West, a distance of 705.45 feet
30	to the northwesterly boundary of the aforedescribed Airport tract; thence along said
31	boundary South 37 degrees 06 minutes 20 seconds West, a distance of 463.05 feet to a 1/2
32	inch rebar; thence South 52 degrees 54 minutes 20 seconds East, a distance of 650.0 feet to a
33	1/2 inch rebar; thence South 37 degrees 06 minutes 10 seconds West, a distance of 847.22
34	feet to the TRUE POINT OF BEGINNING of the herein described easement; thence
35	continuing South 37 degrees 06 minutes 10 seconds West, a distance of 46.45 feet; thence

6	East, a distance of 728.75 feet to a 1/2 inch rebar at a corner of the aforedescribed Airport
7	tract; thence along the boundary of said Airport tract, South 52 degrees 53 minutes 20
8	seconds East, a distance of 1054.9 feet to a 1/2 inch rebar; thence South 37 degrees 06
9	minutes 20 seconds West, a distance of 9397.55 feet to the TRUE POINT OF BEGINNING

17	preclude Grantee's right to withdraw groundwater.
18	SUBJECT TO existing leases, licenses, agreements, easements, utilities, conditions,
19	reservations, restrictions and roadways of record or now in effect.
20	ALSO SUBJECT TO reservation by the United States of America of any uranium, thorium,
21	or other materials which are or may be determined to be peculiarly essential to the
22	production of fissionable materials, whether or not of commercial value, together with the
23	right through its authorized agents or representatives at any time to enter upon the lands and
24	prospect for, mine, and remove the same as noted in document filed for record in Miller
25	County Deed Book 72 at page 312.
26	2. The commissioner of administration shall set the terms and conditions for the conveyance
27	as the commissioner deems reasonable. Such terms and conditions may include, but not be limited
28	to, the number of appraisals required and the time, place, and terms of the conveyance.
29	3. The ordinances of the City of Osage Beach shall be in force and effect on land conveyed
30	under this section.
31	4. The attorney general shall approve the form of the instrument of conveyance."; and

33	Further amend said bill by amending the title, enacting clause, and intersectional references
34	accordingly.
