FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Natural Resources** assume the proposal will have no fiscal impact on their organization.

Oversight notes that the above mentioned agency has stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Officials from the **City of Kansas City** assume the proposed legislation has a negative fiscal impact of an indeterminate amount because it will limit the areas where the city could build a facility.

Oversight notes the proposal <u>allows</u> counties to adopt an ordinance, rule, regulation, or standard relating to solid waste disposal; however, the proposal does not <u>mandate</u> counties to do so. Oversight assumes there will be no <u>direct</u> fiscal impact to the City of Kansas City.

Oversight only reflects the responses received from state agencies and political subdivisions; however, other local political subdivisions were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.
